Cont Depo, near our house at that time my neighbourly
persons namely, (1) Md. Samiruddin s/o Md. Halim,
(2) Sabia Begum w/o Md. Samiruddin (3) Toya Khatun
known (4) Md. Samiruddin (5) Md. Halim s/o Not
known (6) Sata Khatun w/o Md. Halim (7) Md. Samiruddin's
s/o Md. Halim (8) Shabana Khatun w/o Md. Samiruddin,
all one of Nepali Busty, Cont Depo, Vivekananda Nagar,
Ward No. 7 SMC, P.O. & P.S.-Siliguri, (9) Md. Hakim s/o Md.
Shamshad (10) Md. Shamshad s/o Not known (11) Sabir
Khatun w/o Md. Shamshad, all one of Tehiltala,
Mejundar Colony, Ward No. 4 SMC, P.O. & P.S.-Siliguri,
started abusing my said daughter-in-law
languages and when my son Md. Yusuf (21), protested
they all started beating them brutally with feet
& blows and injured them severely, and when my
sister-in-law namely Halima Khatun w/o Md.
Maghbul, protested they caught her & torn off her
saree & disrobed her and their relative
namely, Md. Hasnain s/o Md. Samshad, of Tehiltala
Mejundar Colony, Ward No. 4, P.S.-Siliguri, stolen away
the gold chain of my said minor daughter namely
Aysha Khatun (14).

Sir, my said daughter namely, Aysha Khatun
(14) & my son namely, Md. Yusuf (21) immediately
shifted to Siliguri Distt. Hospital and Aysha
Khatun, admitted there in serious condition and
my son Md. Yusuf, returned getting primary treatment.

The above noted alleged persons are very desper-
ate & dangerous in nature and they have threaten-
ed us for dire consequences, if we will raise
objection, against the visit by their many custo-
mers at their house.

So, please take necessary action against the
above noted alleged persons.
