With due respect, I **MANJU SAHANI**, Wife of Chandresher Sahani, resident of Sahani Busty, Prakash Nagar, Ward No. 43 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal- 734008-begs to state that Barun Sahani, Son of Channa Sahani, resident of Sahani Busty, Prakash Nagar, Ward No. 43 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal- 734008-yesterday at around 9:30 p.m. when my son was going to meet his sister house during the relevant time that the aforesaid person i.e. Barun Sahani wrongfully restraint my son and stated assaulting my son with fist, blows, sharp weapons and liver of the vehicle without any rimes and reason as the consequences my son sustained bleeding and severe injuries in his every parts of body and due to this my son fainted and felt down on the road but even then the aforesaid person not stopped to assaulted my son. Thereafter after half an hour my son was lay down on the road in unconsciousness and my son revive from fainted he saw that the Barun Sahani still sitting behind nearby my son and somehow my son was managed to escaped from Barun Sahani and after seeing flew away of my son that the Barun Sahani started to run after of my son with intention to kill him. That somehow my son reached Sweet Shop. That my tenant informed us about the incident and we rushed to my son at Sweet Shop. Thereafter my son had to be taken to the Siliguri District Hospital for his treatment. That the aforesaid person also threatened my son that he shall kill my son if my son seen in this area or lodge any complaint before any authority. That the above named person is desperate in nature and ample source and there is every possibility that he shall take the law in his hands and can do anything to harm my son.

So I therefore request before you to kindly look into the matter and do the needful to start a specific case against the aforesaid persons under the provisions of law.
