Subject: Filing of FIR regarding theft of Rs. 3,83991 from Reliance Retail Smart Store (TQ22).

Respected Sir/Madam,

I, Mr. Alok Kumar, Assistant Store Manager of Reliance Retail Smart Store, located at 52/1/2583 Sevoke Road, Opposite – Honda Showroom Siliguri would like to lodge a formal complaint regarding a theft incident that occurred at our store. On 02.09.2024, C&A Prabina Baru discovered that a sum of Rs. 383991/- was stolen from the cash safe which is placed on first floor of Manager's Room inside the store. Upon conducting an initial investigation, it is observed that the store's camera DVR had been tampered with, and the hard disk drive was found to be missing. Also, two duplicate keys found from the false ceiling of the server room.

Details of the incident are as follows:

Date and Time of Incident Noticed: 02nd Sept 2023, Time: 09:30am

1. Amount Stolen: Rs. 383991/-
2. Details of Tampering: The DVR, which records the CCTV footage, was found tampered with, and the two hard disk drive containing the recordings are missing.
3. Suspicion: Based on the tampering of the DVR and the missing hard disk drive, it appears that this theft was premeditated, and efforts were made to erase any evidence of the crime.

We request you to kindly register this complaint as an FIR and take immediate action to investigate the matter. We are ready to cooperate fully with the investigation and provide any additional information required. We urge you to consider the seriousness of this theft and act swiftly to apprehend the culprits involved.

2. Photos of the tampered DVR and the location where the hard disk was located.
3. Two duplicate keys found hidden above the false ceiling of server room, one belongs to cash room and another belongs to server room.
