With due respect that I, Smt. Santa Singh, wife of Late Gopal Singh, R/o. Ratanlal Basti, Mallaguri, P.O. Champasari, P.S. Pradhan Nagar, Siliguri -734003, Sir I would like to draw your kind attention to the following facts :-

Around 12 AM in the Night on 01-09-2024, 1. Subojit sarkar, S/o Bhim Sarkar, 2. Gita Sarkar, Wife of Not known, 3. Sonu Sarkar, W/o. Ajay Singh, D/o. Bhim Sarkar all are the resident of Durgaguri, Darjeeling More, Post Office- Pradhan Nagar, Police Station- Pradhan Nagar, Dist. Darjeeling -734003 and 4. Bipul Sonar, S/o Manik Sonar, R/o. Ratanlal Basti, Mallaguri, P.O. Champasari, P.S. Pradhan Nagar, Siliguri -734003, along with Iron Rod, Lathi and sharp weapons they came my house and started shouting, when my sister did not come out in the first place and they broke into the main gate of the house and also broke the showcase and almira started abusing us with filthy languages and asked us to come out furiously, my sister came out of the room and they started assaulting my sister namely Sunita Devi, the said mob started assaulting my sister, in the course of such physical abuse they pulled my sister by hair but she tried to fight back and on that movement they hit my sister on the right side of her head with a wooden "buttam" and somebody again hit her on the left side of her chest.

At that point of time my daughter in law namely Punam Singh, wife of Bijat Singh was there at home and she came out to request the said mobs to leave her and she tried to rescue my sister, but said Subojit Sarkar, Bipul Sonar instead of listening to her, pulled her out of the room started molesting her by grabbing her breasts, they touched her inappropriately and also assaulting her by fist and blows, after some time
