This is to bring to your kind attention that one pair of Distribution Transformer support base channel (100mmx50mmx6mm) & one LT Kiosk support angle (65mmx65mmx6mm) have been found missing from the corresponding distribution sub-station structure (DTR Code: GE061) situated at Bholanathpara (near Kalkaji Glass Factory) & it is assumed that some unknown miscreants have stolen it.

Such notorious act doesn't only cause a financial loss to the tune of Rs. 10,000.00 (approx.) to WBSEDCL but also posed threat to the safety of the network being the distribution transformer & LT Kiosk hanging dangerously that could have resulted into catastrophe if not noticed in time. However, WBSEDCL didn't receive any 'No Power' complain from that area which could have helped us to detect it earlier. However, WBSEDCL has already started to do needful for restoration of normalcy to the earmarked location.

Hence, your good office is requested to take cognizance of the matter & consider this complain as FIR to take necessary action u/s 136 of the Electricity Act, 2003 (read with amendments) & other relevant laws of the land for the theft of WBSEDCL's property.
