Kamlawati Kumari Sha W/o Sri Ashok Sha D/o Sri Baldeo Prasad, resident of Lower Bhanu Nagar, Near Shiv Mandir, P.O – Sevoke Road, P.S – Bhaktinagar, District – Jalpaiguri presently residing at Udlabari Bazar, P.O – Mannabari, P.S – Malbazar, District – Jalpaiguri would like to inform you that on 6 – 5 - 2011 my marriage was solemnized with Sri Ashok Sha S/o Sri Ram Bhajan Sha resident of Chakiya, Rajpur P.O & P.S – Rajpur, District – East Champaran in the state of Bihar according to Hindu rites and customes at my parental house at Udlabari Bazar, Distirct – Jalpaiguri. After marriage I was brought by my husband at my matrimonial house at Chakiya, Rajpur, East Champaran. Be it mention here that as my husband and other in-laws have the business at Siliguri causing I was brought by my husband and other in laws at Siliguri and have started residing at Lower Bhanu Nagar.

During my stay at lower Bhanu Nagar, on 23 - 2 - 2012 I delivered a male child namely Subham Sha at J.B Das Nursing Home, Siliguri and subsequently on 2 - 12 - 2015 I again delivered a female child namely Anushka Sha at Anandalok Nurishing Home. Initially everything was normal till my husband was carrying the business of vegetables and fruits but when he joined service at Sharda Hotel, Hill Cart Road, Siliguri, he started consuming liquire and has started returning home in late night in drunken condition and whenever I raised my objection, he started inflicting physical torture upon me and threat became the part of my life. Subsequently he joined Alishan Bar and Restaurant, Sevoke Road, Siliguri and still he is serving in the said Bar and Restaurant. During his service he came to the close contact with bar girls and started leading his immoral life with the Bar girls and has started supplying the Bar girls to the customers and has fully involved himself in flash trade and Sri Ram Bhajan Sha (Father - In - Law) Smt. Shanti Devi (Mother - In - Law, Sri Binod Sha (Brother in Law) and Smt Prity Sha W/o Binod Sha (Sister In - Law) all are resident of Gupta Building, Gandhi Nagar, P.O - Sevoke Road, Siliguri, P.S - Bhaktinagar, District - Jalpaiguri, inspite of having the knowledge have never restrained him from his said illegal work and whenever I made my complaint before them, they used to threat me not to disclose the fact before anybody.

During his said illegal profession, he came to close relation with one Bar Girl namely Riya who used to perform dance in the said Bar namely Alishan and subsequently he fled away with the said Riya and has started residing with her somewhere else by maintaining his illicit relation with the said Bar dancer but due to my strong resistant my husband agreed to cut his relation with the said Riya and against the disconnection of relation, he had to pay a sum of Rs. 20,000/- to the said Riya.

Though he disconnected his relation with the said Riya but has developed his relation with one Chumki resident of Delhi who is also the bar dancer of the said Bar and has started maintaining his illicit relation with her. On the said relationship of my husband and the said Chumki, several occasions I have been subjected to mental and physical torture from the end of my husband not only that whenever I made complaint before my aforesaid in-laws, they used to threat me with dire consequences and lastly on 17 - 8 - 2024 my above named in-laws have arranged marriage of my husband with the said Chumki and all have fled away from Siliguri when they came to know that I will lodge FIR.

Since the very inception of my marriage, I am subject to mental and physical torture of my husband and in-laws as above mentioned and my husband and my husband on 17 - 8 - 2024they fled away with the said Chumki and my husband married the said lady inspie of existence of his first marriage.
