1. Unknown Bolero Pickup

(Accident held on 31-08-2024
with WB74AP-6590)

Respected Sir,

With due respect, I Sri Bijay Chokhani, Director of Sunshine Overseas Pvt. Ltd do hereby inform regarding the Accident of our above mentioned Vehicle No. occurred on 31-08-2024 near North Bengal Safari. My Vehicle was returning back from Malbazar, then suddenly an unknown Bolero Pickup coming from check post was trying to overtake his side of vehicles in a speedy way that too in the heavy rain. The Pickup trying to overtake suddenly came in his side of the road, blocked his passing and collided with the car with heavy force damaging the car badly and most importantly injured the driver whose name is Bikash Turkey Son of LT. Philip Turkey, Resident of North Point PO, Damanpur Dist- Alipurduar Pin - 736123 having DL No. WB-6920110855853 and two my lady relatives whose name is Babita Kagliwal wife of Sanjay Kr. Kagliwal, Resident of 12 No Ward, Haren Mukherjee Road, Hakimpara, Siliguri, Dist- Darjeeling, W.B. Pin Code - 734001 and having Aadhar No. 6995-7614-6048 and other lady is Bandita Jaishi wife of Ashok Kagliwal, having Aadhar No. 5913-0215-0828. The accident had very much major impact on the driver and my two lady relatives. Due to the major impact the Air bag was open so that driver was saved from the impact but due to heavy force collision the driver incurred injury in his head, hands and also in his legs. The major relative effected due to this accident was Babita Kagliwal who was sitting just back of the driver seat. The force was so much that she got major injury to the head resulting 26 stiches in her head and also both of her legs got fractured. Also full body checkup is in process. Initially they all are admitted in Anandaloke Hospital for their treatment. The Third Lady relative who was her sister-in-law was sitting beside her but she didn't had any major injury. Just some minor injury on her hands and legs. Due to the impact Babita Kagliwal became unconscious. When she was unconscious, she lost or someone took her Pendent, Locket and Gold earrings of both side ears. The driver and my lady relatives are till now so much traumatized due to this accident. The driver & lady was saved only because of the Grace of God otherwise it's impossible to be saved from this fatal accident.

So, I request the higher Authorities for proper enquiry and investigation and find the unknown Bolero Pickup whose number is not yet found and take necessary action against the culprit and provide justice.
