Sir,

While I was posted at Malda, on 29.08.2024 (Evening) it came to my knowledge that one accused person namely Bimalesh Mallik, S/o Kamudaprasad Mallik of Deshbandhu Para, Siliguri had stolen away grill, window, door from my house at Deshbandupara, Tara Shankar Road, Siliguri (under Siliguri Municipal Corporation having Holding No. New/202/2001) and it was informed to Siliguri, Control Room over Telephone. The accused Bimalesh Mallik is a mafia under Shelter of Political party. After prolong and protected torture and applying criminal force, he forcibly snatched away our land and building which has been duly informed to Siliguri Police Station. As a result, we cannot enter into our premises to look after its safety and security. Therefore, the accused Bimalesh Mallik is sole responsible for the above noted theft. The following atrocities were informed to you previously: -

- 1. When we came to Siliguri from Coochbehar, the accused Bimalesh Mallik wrongfully restraint our entry into our house and thrown acid on my wife which refers to Siliguri P.S Case No. 622/13.
- 2. whereas, we were asked for withdrawal of the case with a threat of dire consequence of life and he lodged a false complaint against me to put pressure on me which refer to Siliguri P.S Case No.659/13. After trial it was proved before Court that the case was false.
- 3. when his mother Safali Mallik become missing at that time, I was 90% disabled and was bed ridden. Inspites of that, the accused Bimalesh Mallik lodged a false kidnapping case against me which refers to Siliguri P.S Case No. 744/2017.
- 4. Whereas, on 24.06.2019, the accused Bimalesh Mallik traced out his mother's dead body within their well and spread a false rumour against me that I have murdered his mother namely Safali Mallik. As a result, huge mob consisting notorious criminal tried for mob lynching against my family. In the meantime, DCP, Gouravlal Sir and others rescued us. Since then, we are not allowed to enter into our native home. In Newspaper and electronic media, he threatened us from debarring to enter in our home in any condition. On that day (24.06.2019) my family members were seriously assaulted and my mother succumbed to her injury on 19.10.2019.
- 5. whereas, on 21.02.2021 it was came to my knowledge that all the household articles were stolen away and FIR was lodged in Siliguri P.S by me. When I visited with I/C, Siliguri P.S, the accused Bimalesh Mallik did not allow me to enter into my house and misbehaved with me, as a few days ago all his above atrocities were informed to my higher authority to take action. It was duly recorded by I/C Siliguri P.S by video recording.

- 6. Whereas, on last month while I brought the matter before the Hon'ble DGP, W.B sir regarding atrocities and lawlessness, resulting a high level of enquiry which was started by our Authority. As a result, on 29.08.2024 the accused person intentionally stolen the abovementioned articles with a criminal approach for demolition of my house and to put pressure on me. On 21.08.2024 while I had been to Tarasankar Road to see my house from distance the accused person started pelting stone on me. The accused person wilfully committed such types of nuisances with me and my family whenever, we became face to face. It was reported to your Police Station several times.
- 7. Whereas the accused Bimalesh Mallik and his family members forcibly kept my land and building under their illegal custody. As I along with my family members dwelling in a rented house at 40 Ramkrishna Sarani, Siliguri 6. Hence, all the dues viz, SMC tax, Electricity bill, Land tax should be incurred from the accused Bimalesh Mallik as a punishment, as they forcibly snatched away my land & building and debarring from our entry in our house. He is also responsible for the crime of theft and mischief which took place on 29.08.2024 in my house. He knowingly and intentionally never informed the matter to the Police Authority regarding the theft in r/o my house as he is self-involved in this criminal activity.

Therefore, I pray to kindly start a case and to punish the actual culprit after investigation.
