Last night date 29/08/24 around 8'o'clock he said to me that he found his vehicle at Siliguri near Sonar Petrol Pump, but there is no material in that vehicle. Only, he had found a bucket of Hydraulic oil. He said it was for him. Today, I have contacted Mr. Vijay by phone so many times, he said that he will try to solve my problem. But I am not getting any positive result from him.
