I managed to run hard and escape from there.

We need to visit this area on a regular basis as a part of our regular official duty. We are very scared and suffering from a sense of insecurity. As a bank we are dealing with Public money and being a custodian of public money we need to carry out our official duty in that area. Therefore, it is our humble request to ensure that bank employees are protected from these kind of deadly miscreants. In light of the given circumstances request you to take necessary legal action as permitted under due process of law.
