Sub: - Letter of Complaint against Proprietor of Sanjeet Gas Service Centre for illegal refilling of Gas Cylinder

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

- (i) 03(Three) Number of Indane Domestic Gas cylinder partial loaded each printed as Net weight 14.2 kg , Gross weight 29.2 Kg (approx).
- (ii) 02 (Two) Number of empty Indane domestic Gas Cylinder weight approx 14.2 Kg.
- (iii) 02 (Two) number of empty Non- Branded small Gas Cylinder weight approx 3 Kg 100 gm
- (iv) 01 (One) number of loaded Non- Branded small Gas Cylinder weight approx 6 Kg 100 gm.
- (v) One pcs Gas Refilling nozzle which used for gas refilling.

I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Sanjeet Das S/O Sukumar Das of Vill- Jamurivita, PO- Sahuddangi, PS- NJP, Dist- Jalpaiguri to the effect that on 05/09/2024 at about 12:05 hrs received a secrete source information that one Sanjeet Das of South Colony Bazar, Gandhi More, New Jalpaiguri is illegally storing, refilling and selling Domestic LPG cylinders i.e. Indane at his shop styled as "Sanjeet Gas Service Centre" for the purpose of refilling and selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No. 32 Dt. 05.09.24 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector Samrat Mitra, ASI Arghya Das, L/C 1270 Deeptina Gazmer all of EB, SPC left EB Office to proceed South Colony Bazar, Gandhi More, New Jalpaiguri to execute the information. This refers EB, SPC GDE No. 33 Dt. 05.09.24 and C.C. No. 61/24 Dt. 05.09.24.

At about 12:55 hrs we reached at South Colony Bazar, Gandhi More, New Jalpaiguri and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the shop of "Sanjeet Gas Service Centre" and found that the above noted accused person is busy to refilling from the big size Indane gas cylinder to small size non branded gas cylinder. On searching, the above noted seized articles have been recovered from his shop. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Sanjeet Das S/O Sukumar Das of Vill- Jamurivita, PO- Sahuddangi, PS- NJP, Dist- Jalpaiguri is storing, refilling and selling the Domestic cylinders in his shop for his wrongful gain. As per local enquiry it came to light that the above noted person refills gas in violation of

safety requirements thus conducted negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that bazaar area. Sanjeet Das does not have any valid License/ Permit of dealing /distribution /refilling LPG. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of local witnesses namely 1)Sunny Chowrashia S/O Ashok Chowrashia of South Colony Mazdur Basti Over Bridge, PS- NJP and 2) Ratan Biswas S/O Lt Madho Biswas of Vill- Jamurivita, PO- Sahuddangi, PS- NJP, Dist- Jalpaiguri. The seizure was made in between 13:15 hrs to 13:55 hrs.

Hence, I pray that a specific case may be recorded against the accused persons namely Sanjeet Das S/O Sukumar Das of Vill- Jamurivita, PO- Sahuddangi, PS- NJP, Dist- Jalpaiguri and others
