I, Prabhakar Gupta, Son of Late Sashi Nath Gupta, resident of Haripur Gowala Busty, P.S. New Jalpaiguri, Dist. Jalpaiguri, like to inform you that on 01.09.2024 at about 11:30 p.m. I was standing left side on the kutcha portion of the road with my vehicle (E-Scooty) at Chhat Pukur, Near Hanuman <sup>Mandir</sup> Haripur at that time one Motorcycle bearing Registration No.WB-74AW-2477 coming from opposite direction at high speed being driven rash and negligent manner dashed hit me and my said E-Scooty. As a result of which I fell down on the road and sustained severe injuries in my right leg and right hand and also badly damaged my said E-Scooty. Thereafter, immediately by the help of the local people I went to N.J.P. Railway Hospital and after stitching in my leg and hand I discharged from there and my treatment is still going on.

Thereafter on the next day i.e. on 02.09.2024 I know from my reliable source the name and address of the rider of the said offending Motorcycle being No.WB-74AW-2477 is Rahul Singha, S/o Tapan Singha, resident of Ambika Nagar, Road No.2, P.S. New Jalpaiguri, Dist. Jalpaiguri.

That due to such accident I was in bed ridden condition and do not move/walk anywhere, so the delay is caused for lodging this F.I.R.

I, therefore request you to kindly take necessary legal steps against the rider of said Motorcycle being No.WB-74AW-2477 and oblige.


