Sir,

With due respect I would like to inform you that, I am Sri Deo Raj Rai, S/o Late Jagat Bahadur Rai, resident of Dudhgate, P.O. Dulaljote, P.S. Kharibari, Dist. Darjeeling, PIN – 734429. That I am the absolute owner of the mentioned below schedule land and after purchasing the below schedule land, I have peaceful enjoyment of the schedule land. That after purchasing below schedule land some dispute arise in between myself and (1) Asha Mittal, W/o Kailash Nath Mittal, (2) Kailash Nath Mittal, S/o Kundanlal Mittal, both are resident of Sevoke Road, P.O. & P.S. Siliguri, Dist. Darjeeling, PIN – 734001, (3) Hemant Sitani, S/o Lt. Nirmal Kumar Sitani, residing at Dinbazar, P.S. Kotwali, P.O. & Dist. Jalpaiguri, PIN – 735101, (4) Saket Agarwal, S/o Narendra Agarwal, residing at Jalpaimore, P.O. & P.S. Siliguri, Dist. Darjeeling, PIN – 734001 and thereafter I filed a Civil Suit before the Civil Judge (Junior Division) at Jalpaiguri against mentioned above persons on 21.12.2023 and the same Ld. Court after perusing my all documents and pleased to pass the order:- “That the prayer for an order of ad-interim injunction is allowed.

that the defendants and their men and agents are hereby restrained from causing interference in the peaceful acts and possession of the plaintiff and forbidding them from encroaching any portion of the suit property forcibly till 18.01.2024.” After that the said injunction order was extended till 12.09.2024 by the Ld. Civil Judge (Junior Division) Court at Jalpaiguri.

That the said order of the Ld. Court has been communicated to the defendants by post but in spite of the order of the Ld. Court, the defendant has been infringing/violating the said order in the mentioned below schedule land in the plaint. That presently on 22.02.2024 at about 11:30 a.m. the defendants along with some antisocial persons were encroaching and also to make construction forcibly and illegally violating the Order of the Ld. Court.

In the above facts and circumstances, I would like to bring this information for taking necessary action, so that solemn order of the Ld. Court is and be maintained.
