household items related to constructing were also missing. Then when we carefully looked at the CCTV footage, we came to know that a boy entered into our house at around 6:50 AM. He found that CCTV cameras are installed in the house, he disconnected all our cameras and WiFi. After disconnecting the camera, he stole some materials which were missing and went away.

This is not the first time, even before theft has happened in my house on 18/8/24 and the FIR no. related to that theft is 815/24.

Please treat this note as an official complaint and record it in the FIR. You are requested to interrogate the local suspects and black listed bellows to find out clue to this matter and take necessary legal action in this regard.

I hope the police will take immediate steps regarding this matter for which we shall be grateful to you.
