Darjeeling, like to state that on 03.08.2024, at 11:00 PM I was returning to my home from Venous More, on the way near Alupatty near underpass when I reached there some antisocial four to five, intercepted me and they started assaulting me with stick and blows. I was hit on the back side of my head with bamboo and I felt on the ground and senseless. Those antisocial thought I was dead. That those person also looted away my purse in which a sum of Rs. 22,000/- was kept and also took my I phone 15+ of apple. After that some passerby took me to my house. Very next day I had collected the video footage through CC TV for this incident.

I therefore my humble request you good self to look into the matter and took those culprit according to law and oblige.
