Respected Sir,

With due respect I, KUNDANI CHAUHAN, Wife of Dilip Pradhan @ Pritam, Daughter of Chhote Lal Chauhan, resident of Tripali Jote, Baniakhari, P.O. Nimai, P.S. Matigara, Dist - Darjeeling, West Bengal - 734010 begs to state that my marriage was solemnized with Dilip Pradhan @ Pritam, Son of Late Narayan Pradhan, resident of Putimari, Bhujia Pani, P.O. & P.S. Bagdogra, Dist - Darjeeling, West Bengal on 16.02.2023 at my aforesaid place of residence under Hindu rites and customs. That soon after the said marriage the aforesaid (1) Dilip Pradhan @ Pritam, Son of Late Narayan Pradhan, (2) Smt. Nanu Pradhan (Mother-in-Law), Wife of Late Narayan Pradhan and (3) Shikha Pradhan (Sister-in-Law), Wife of Raju Thapa, residents of Putimari, Bhujia Pani, P.O. & P.S. Bagdogra, Dist - Darjeeling, West Bengal started physical and mental torture upon me with regard to my caste and community. That the aforesaid persons kept all my stridhan with themselves soon after the marriage was over. The episodes of torture used to continue on a daily basis as I was never allowed to do household works and I was not provided with food. I was not allowed to enter the kitchen and cook any food for myself or the family. Out of our wed lock one male child was born on 04.11.2023 named Ivaan Pradhan. After the birth of the child I thought that the conduct of the aforesaid persons would change but the physical and mental torture grew even more. I was not provided with sufficient food for the adequate nourishment of myself and my breastfeeding child. Subsequent to that my child Ivaan Pradhan got seriously ill and as I pleaded before the aforesaid persons to show mercy upon the child and consult a Doctor, the aforesaid person, in turn started to torture me. After the torture continued and never stopped I requested the aforesaid persons for a proper treatment for our child but the aforesaid person in turn chased me and my child from their home i.e. their matrimonial home on 03.06.2024 and told me never to return back. That after me and my child was chased away from my matrimonial home I found no other option but to return to my parental home with my child. After I reached my parental home and after seeing me and my child's condition, my father consulted a Doctor and my child was admitted on 03.06.2024 at Mukta Nursing Home, Matigara and discharge on 06.06.2024. That even after being aware of our child's condition and his treatment none of the aforesaid persons ever visited the child nor contacted me and my family to know my and my child's whereabouts.

That yesterday i.e. 02.09.2024 the aforesaid Dilip Pradhan came to my parental home at about 8 P.M. I was relieved and hoped that he had come to reconciliation but in turn the aforesaid Dilip Pradhan was in drunken condition and started to abuse me and laid hands on me. He further abused my father and my family members as well and threatened them stating that he shall spoil my and my child's life. The aforesaid Dilip Pradhan and his family have kept all my gold and silver ornaments with them and the aforesaid Dilip Pradhan has never assisted/ help me and our child for our livelihood.

So, I therefore request before you to kindly look into the matter and do the needful and start a specific case against the aforesaid persons under the provisions of law.

I shall be highly obliged for this act of kindness.
