- 4. That on 24/08/2024 when my husband went to his sister's house he saw someone trying to fencing my said land with bamboo. When my husband asked him who is he and what he is doing in my land. He introduced himself Bibek Dutta and he claimed the land belongs to him. After that few of my neighbors of that land came out and protest against him, and he fled away from the land with all his bamboo and other articles.
- 5. That on 06/09/2024 at early morning again he came to my said land with few labour and unknown persons (when my husband was in Alipurduar and I was in Rajganj) to make tin shed structure on the said land. One of my neighbor of that land Sri Dijendranath Roy saw this and protest again him saying that this land belong to Smt. Soma Banik (Ghosh).
