I, Sri Chetan Anand S/O Sri Anand Kumar Dwivedi of Belakoba Customer Care Centre do hereby lodge a complaint being empowered by Electricity Act-2003 against Sri Kalyan Sarkar S/o Sri Lt Jitendra Mohan Sarkar of Vill- Kamarvita, Ambari, Jalpaiguri was committed theft of Electricity under section 135(1)(e) of the electricity act 2003 as station here under.

On 02.09.2024 at about 13: 00 hrs I accompanied by T.S.H, Sandip Talukdar (43 years) S/O Late Akhil Bandhu Talukdar and Raju Dutta (29 years) S/O Sri Late Sadhan Kumar Dutta attached to Belakoba C.C.C WBSEDCL and S & L.P team of Jalpaiguri Regional Office (Sri Paritosh & Special Officer Sri Santa Seal) hold raid and inspection at Vill- Kamarvita, Ambari, Jalpaiguri P.S -Bhorer Alo. In course of inspection we entered to the premises of Sri Kalyan Sarkar (67 years approx.) S/O Lt Jitendra Mohan Sarkar. He was present at the time of inspection. During inspection we noticed that Sri Kalyan Sarkar (User) {Consumer no-422126002} is enjoying electricity from Domestic meter to his commercial shop unauthorized.


Power theft was detected. **No articles were seized** and the raid was conducted in presence of local witness Sri Titun Roy at 13:05 hrs also in presence of Sri Santa Seal and Sandip Talukdar under P.S Bhorer Alo and duly signed by them.

Sri Kalyan Sarkar (67 years approx.) is an accused person who has committed theft of power of U/S 135(1)(e) Electricity Act. You are requested to take cognizance of this complaint and treat this as F.I.R.
