I Faij Ahmed, son of Faied
Ahmed, Advocate by profession, member
of Jalpaiguri District Court, resident
of Ashraf Nagar, P.S. Bhaktinagar,
Dist: Jalpaiguri, beg to state as follows:

→ That today around 2:30 pm my
younger brother received a call
from an unknown number being
"8906419507" wherein the person
stated that "I am from Siliguri
Police Station officer Tanveer Hameed S.I.
aapka naam pe case hua hai aap
kaha aas". When my brother asked
him what case, he did not reply and
disconnected."

→ on knowing this I called back on the above mentioned number and the said person again told that "Case kha hai bhai ko lekar aao, phere rako abhi disturb mat karo"; after which I went to the police station (Selegiri Police Station) to enquire about the matter whereon I found that there is no officer (SI) with the name of Tarneer Malik.

→ later on we realized that it was a fake call and the said person was trying to extract (extrakt) money from us by pretending to be a police officer.

- That the said person is not an officer and is a fake caller trying to extort money and do various acts.

I kindly request you to take immediate action against the above named person (along with phone number) as soon as possible.
