Mahato, resident of Santoshi Nagar, Ramjanki
Road, P.S. Siliguri, Dist. Darjeeling would
like to state that on 10.9.24 at about 8.00 p.m.
when my son namely Ritik Mahato was sitting
at the Mandal where Ganesh Puja was being held
at that moment a person namely ① Praduman
Paswan and ② Somu Paswan, both sons of Maheswar
Paswan @ Musu came towards my son and
started to abuse me and when my son tried

to ask about the same they i.e. above noted persons
pressed the neck of my son and pushed him
into the road and started to assault him
with bricks and stones and seeing the same
I rushed to the spot and tried to protect my
son.

It is important to mention here that when
I reached at the spot brothers of the above noted
person namely ① Shaleb Paswan, ② Bikash
Paswan ③ Chandan Paswan all are sons of
Maheswar Paswan and with them

above noted persons pulled me and pressed my mouth so that I cannot shout and dragged me by holding my hair and saree and they they started to Assault me with Criminal force and intention and also disrobed me and when I shouted for my help at that moment they started to assault me with fist and blows and with bamboo sticks and stones for which I have sustained severe injuries in my head in my face as well as all over my body parts. and when my small daughter namely Anisha Mahato came to save me they also did not spare her and caught her and thrown her at the drain and after that Person namely Meena Paswan, w/o. Maheswar Paswan came to the spot and started to assault my younger daughter.

It is also important to mention here that the above named person namely Raduman Paswan threatened me and my son as well as my whole family that if we ever lodged any complaint about this incident "they will kill us and our body will be not found". Thereafter seeing this local people came to the spot and took us to the Siliguri Sarda Hospital and I was admitted there for 1 day. It is also important to mention here that they have also stolen my "Mangal Sutra" and my ear rings which was made of gold.

Thereafter finding no other alternative ways today with the help of my well-wishers came before you to lodge this written complaint against the above noted persons.

Therefore I kindly request you to take necessary legal steps against the above noted persons and for the ends of justice.
