her brutally with fist & blows and injured her
severely. My said mother, Mina Debi immediately
shifted to Siliguri Dist. Hospital & treated her
there.

Sir, the above noted alleged persons are
very despotic & dangerous in nature and they
have threatened me, my brother namely, Subodh
Paswan (25) s/o Sri Maheshwar Paswan and
my relative namely Sonu Paswan (14) s/o Sri
Rontku Paswan, all are of Near Ranjales Mandir
Santoshinagar, Dist. West, P.S. Siliguri, for
dere consequences, if I will demand my loan
amount from said Ritik Suri.

So, Please take necessary action against
them.
