My marriage with Bikey Gupta took place on 19/01/18 at Khalpara, Shivajee Road, ward No-8 Siliguri. Since our marriage, I have been subject to mental and physical torture by my husband namely Bikey Gupta, My mother-in-law Fulmati Prasad, father-in-law Motilal Prasad and sister-in-law Rinku Prasad, Rina Gupta and Purja Shah, due to their dissatisfaction with the dowry provided by my family. They frequently used abusive language against my family members and assaulted me several occasions, demanding more money from my family.

On 20/10/2019, I have birth to our daughter, Reshu Gupta. After her birth the mental torture escalated, particularly because they were disappointed that I gave birth to a girl instead of a boy. After 3 years it was found that our daughter was suffering from autism and which their cruelty intensified.



They blamed me for our daughter was suffering child's condition, further increasing the mental and emotional abuse. After discovering that our daughter on 05/08/24, I gave birth to another baby girl at Siliguri District Hospital. My husband was present during the delivery. However on the next day 06/08/24, my husband and in-law did not later ~~late~~ visit me at the hospital, their phones were switched off and remained without food the entire day later I learned from my family members that my husband, mother-in-law father-in-law and sister-in-law Rinky Prasad had taken my elder daughter, Reshu Gupta and left our home under lock and key.

I humbly request you to take immediate and necessary against my husband, Bikey Gupta and his family members for domestic violence, mental and physical cruelty and I also request you to ensure the safe return of my elder daughter Reshu Gupta.
