Respected Sir,

I, Sri Indrajit Saha, son of Sri Ranjit Saha, resident of  
Ashrampara, Pakurtala More, Siliguri, Darjeeling would like to bring to your  
kind notice the following facts:

I am the absolute owner of land measuring about 450 sq.ft.  
equal to 10 chattaks or 1.035 decimals, recorded in khatian no 5848 plot  
number 2255 situated at Bidhan Road in between Audio Vision and India  
Zarda House. I purchased the said land by a registered deed of sale being  
number 1816 for the year 2013 from the legal heirs of late Gokul Chandra Paul.

I had filed a suit for partition and other reliefs against  
Sumitra Rani Paul and others which was registered and numbered as Title  
(Partition) Suit No 20 of 2021. In the said suit I had also prayed for injunction.  
The Ld. Civil Judge, Senior Division, Siliguri on 20.03.2023 was pleased  
enough to dispose of the said injunction application by passing an order which  
directed both the parties to the suit to maintain status quo till the disposal of  
the suit. Photocopy of the certified copy of the said order is annexed herewith.

Yesterday in the late hours I noticed that the defendants  
have brought on a JCB on the suit land clearly in violation of the Ld. Court's
