Subject: FIR against Deepak Yadav (8791790391), Pratigya Basnet (9907031152, 9832740493) for Blackmailing and for Unauthorized Sharing of Private Video

I, Gouri Shingh, D/O of Mr Dayal Shingh, Indiria Pally, Shivmandir, PS Matigara, Dist. Darjeeling 734011 would like to file a complaint regarding a video that is currently being circulated. Initially, Deepak Yadav S/O Mr Tikaram Yadav, Daluhera, Meerut, Uttar Pradesh 250501 and I started as friends, and over the course of 4-5 months, our friendship evolved into a relationship, though I cannot recall exactly when this happened. As our relationship progressed we became more intimate, then we began engaging in voice and video calls, including some that were private.

Later I discovered that Deepak is a married man with a family. Realizing that I did not want to disrupt his family life or hurt his wife, I decided to end the relationship. When I began ignoring Deepak, he threatened to circulate a private video of me and demanded Rs 10,00,000 out of which I didn't pay.

Later, Deepak came to Siliguri and insisted that I meet him. On his request I booked a room at Hotel Savera on 17<sup>th</sup> Dec.2023 as he had threatened me saying that he would harm me by throwing acid and blackmailed me if I did not comply with his demands he would leave me nowhere. Out of fear, I stayed with him overnight at Hotel Savera on 17<sup>th</sup> Dec. During my stay, as I was unwilling to be physically involved with him. After that Deepak started coordinating with my colleague, Pratigya Basnet, D/O Ajay Basnet, behind SNT, Pradhan Nagar (Local Address) Permanent Address (Ajay Basnet, Pokhriabong Busty No.2, Lower Lepcha Goan, P.O Pokhriabong, P.S Sukhia Pokhri Darjeeling West Bengal 734216) regularly, and sent her the private video. Pratigya, who was aware of my relationship with Deepak, subsequently forwarded the video to Swarup Sarkar (9073135480) with the intention of damaging my reputation and causing me disgrace.

Furthermore, Tahid Sarkar, (7864903739) who viewed the video during a live video chat with Pratigya, was recorded by Sakil Rahman (9647709767). This recording, along with the personal video of me and Deepak, has been forwarded to their classmates by Sakil, exacerbating the breach of my privacy. Sakil and Tahid are presently working at Baba Lokenath Physiotherapy Hospital, Darjeeling More, Siliguri as per my knowledge.

Below are the names of individuals involved in the circulation of my private video, which constitutes a criminal act and is against the law:

I request that appropriate action be taken to address these serious violations of my privacy and to prevent further harassment. Additionally I plead and request that legal action be taken against Deepak Yadav involved in threatening me and against Pratigya Basnet for unlawfully circulating my private videos to harm my reputation. I seek justice as I have been trapped, blackmailed, and subjected to severe emotional distress which has affected my personal life and mental peace. I pray that justice is served and that the culprits are arrested and held accountable as soon as possible.
