I, Smt. Arati Manna, aged about 56 years, wife of Sri Barun Manna, presently residing at South Ektiasal, Oppoosite of Nava Jyoti Sangha club, Pipe Line, P.O.- Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, beg to inform you that on 09/03/2023, my son Sri Bimalendu Manna got married to Smt. Lipi Das, daughter of Sri Krishno Das, permanent resident of Majhabari, P.O.- Bhaktinagar Dist. Hindu rites and rituals. Ghogomali, P.S.- Jalpaiguri, according to Hindu rites and rituals.

At the time of marriage neither we demanded nor the parents of my daughter-in-law gave any dowry or any kind of gift to my son as they had no capacity and my daughter-in-law and her parents gave their consent to the marriage representing themselves very compromising and understanding, knowing very well that my son earns very little as he works as an assistant of physiotherapist in a private chamber. After the marriage, my daughter-in-law came to our above mentioned address with my son to live their conjugal life and we also accepted her as our own daughter. But just after a few days we found my daughter-in-law to be very greedy, rude and jealous in nature and a lady of high per temper. She always used to provoke my son to throw out me and my aged husband from our home. She never performed any conjugal duty towards my son and moreover she always used to insult us for our low financial status and abuse my son for his incapacity to fulfil her sky high illegal demands. I used to try to convince my daughter in law to adjust with us and advice my son to keep patients hoping that after a few days everything would be all

right. But my daughter-in-law's illegal expectations and intolerance increased day by day. She used to insist my son to lead an ultra-life like drinking and freaking out with which our family was not son to lead an ultra-life like drinking and freaking out with which our family was not accustomed. On every small incident she used to shout at us with filthy languages. She used to pressurize me and my husband repeatedly to transfer half of our dwelling house in her name claiming it's her right and on refusal, in the month of August, 2023, my daughter-in-law abused me mentally and physically with filthy languages, fists and blows. Being very frustrated, I attempted to commit suicide consuming huge number of sleeping pills and got admitted in Siliguri Hospital and afterwards in North Bengal Medical College and subsequently got well. As my daughter-in-law got pregnant, we became very happy and took all measures to take care of her health from our end but she never took care of her even brutally declaring that she was not willing to become mother of a child of our family and for her carelessness she had miscarriage in the middle of the month of May, 2024.

In the last week of July, 2024, without any reasonable ground, my daughter-in-law started quarrel with my son and threatened us saying that her family is very well known to the local political party and with help of them, she would kick out me and my husband from my home. As I tried to calm down my daughter-in-law, but suddenly she started beating me with blow, fist and kicks. My son and my husband rescued me in any way. On that very day, my daughter-in-law, without informing us left our house along with all her belongings and went to her paternal house as mentioned above. Considering the status of our family, we did not inform to the police, but three days before my daughter-in-law started to threaten me and my son saying that, if we transfer half of the dwelling house in her name, she would continue the marriage with my son otherwise she would take steps to break

down the marriage realising Rs. 20,00,000/- from my son. And if we do not agree with her proposal, she would put us behind the jail bringing several false allegations against us.

Under these circumstances, I am totally helpless having no clue as to what should I do. So, considering my situation I request you kindly to take necessary and urgent steps as you deem fit.
