In producing herewith following three accused persons namely i) Iswar Sonar (22year) S/O Madan Sonar of Bhabasindhu Colony ward no 42, PS Bhaktinagar Dist Jalpaiguri, ii) Jiwan Boro (27years) S/O Hanaq Boro of Dalep Adarsh Gaon, Singtam, Dist West Sikkim, A/P Bhabasindhu Colony ward no 42, PS Bhaktinagar Dist Jalpaiguri, iii) Kano Roy (28years) S/O It Kalicharan Roy of Salugara Vivekananda, Bhandari Mandhir, PS Bhaktinagar Dist Jalpaiguri with following seized articles viz:

- 1) One Iron made Bolt Cutter recovered from the exclusive and conscious possession of Iswar Sonar.
- 2) One iron made knife recovered from the exclusive and Conscious possession of Jiwan Boro.
- 3) One iron made Hacksaw blade approx 12 inches recovered from the exclusive and conscious possession of Kano Roy

I, SI Youel Lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted i) Iswar Sonar (22year) S/O Madan Sonar of Bhabasindhu Colony ward no 42, PS Bhaktinagar Dist Jalpaiguri, ii) Jiwan Boro (27years) S/O Hanaq Boro of Dalep Adarsh Gaon, Singtam, Dist West Sikkim, A/P Bhabasindhu Colony ward no 42, PS Bhaktinagar Dist Jalpaiguri, iii) Kano Roy (28years) S/O It Kalicharan Roy of Salugara Vivekananda, Bhandari Mandhir, PS Bhaktinagar Dist Jalpaiguri and 8/9 others to the effect that on 13.09.2024 at 00:30 hrs received a specific source information that 11/12 miscreants have assembled at Gandhi Math under Bhakti Nagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 699/24 dated 13.09.2024 and as per order I along with SI Rantu Haldar, ASI Amardeep Chhetri, ASI Dipak Karmakar, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Gandhi Math under Bhakti Nagar PS, to work out the information in hand.

At about 00.45 hrs we arrived at Gandhi Math under Bhakti Nagar PS, as indicated by the source we noticed that 11/12 persons assembled at Gandhi Math under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 8/9 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 13.09.2024 in between 00.55 hrs and 01.25 hrs. The whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely i) Iswar Sonar (22year) S/O Madan Sonar of Bhabasindhu Colony ward no 42, PS Bhaktinagar Dist Jalpaiguri, ii) Jiwan Boro (27years) S/O Hanaq Boro of Dalep Adarsh Gaon, Singtam, Dist West Sikkim, A/P Bhabasindhu Colony ward no 42, PS Bhaktinagar Dist Jalpaiguri, iii) Kano Roy (28years) S/O It Kalicharan Roy of Salugara Vivekananda, Bhandari Mandhir, PS Bhaktinagar Dist Jalpaiguri and others kindly arrange for its investigation
