Miguri Police Commissionerate In producing herewith one arrested female accused person namely Aparna Malo (F-31yrs) w/o Kanchan Malo of Chottofapri PO, Sevok road PS- Bhaktinagar, Dist.- Jalpaiguri along with the following articles under proper seizure list: -

One red color plastic container containing 5 (five) liter of 'illicitly distilled liquor locally called (i) as "CHULLU" and marked as "Exhibit-A". Out of which 01 (One) liter taken as sample and marked as "Exhibit -A-1". MRP of Rs, 80 X 5 /= 400/=

One plastic (bottle) containing 1 (one) liter of 'illicitly distilled liquor locally called as (ii) "CHULLU" and marked as "Exhibit-B". Out of which 500 ml taken as a sample and marked as "Exhibit – B-1". MRP of Rs, 80/=

I, ASI Dinesh Ch Roy S/O Late Madhu Roy of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted female arrested accused person namely Aparna Malo (F-31yrs) w/o Kanchan Malo of Chottofapri PO, Sevok road PS-Bhaktinagar, Dist.- Jalpaiguri to the effect that on 13.09.2024 at 16.00 hrs. I received a reliable source information that one female person is selling illicit liquor in his house at Chottofapri PO, Sevok road under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No 404, Dated 13.09.2024, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force including lady constable 1234 Hira Roy had been to Chottofapri PO, Sevok road under PS - Bhaktinagar Dist.- Jalpaiguri to verify the veracity of the information in hand. On reaching there and as identified by the source we cordon the house and held a raid one female accused managed to apprehend by the lady constable 1234 Hira Roy. On being asked she disclosed her identity as noted above also stated that she is selling illicit liquor from her house without any valid license for her wrongful gain during raid some customers are managed to flee away from the spot. On further search, the above-noted seized articles were recovered from her house. On-demand she failed to produce any valid license/papers for selling and storing such articles. On further interrogation, Aparna Malo stated that she had been involved in selling and possessing liquor without any valid license for the last few months for her illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the above-mentioned female person named Aparna Malo u/s 35 BNSS 2023 after observing all sorts of formalities at the spot to maintain her modesty also inform her ground of arrest. The whole process of seizure and label has been made in between 17.00 hrs to 17.15 hrs the whole process of search and seizure under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Aparna Malo (F-31yrs) w/o Kanchan Malo of Chottofapri PO, Sevok road PS- Bhaktinagar, Dist.- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
