Sir,

I, Smt. Manju Kundu, Wife of Late Dr. Anup Kundu, residing at 22/3A/6, Srinath Mukherjee Lane, Kolkata – 700030, beg to lodge this complaint as under :

1. That my husband, Dr. Anup Kundu (since deceased) was a Medical Practitioner and during the period of 1991 to 2001, he was attached to North Medical College & Hospital as the Head of the Department of Urology.
2. That during the said period, my husband, Dr. Anup Kundu (since deceased) on 26.04.1995, purchased a plot of land measuring 2 Katha 13 Chhatak 30 Sq.ft. situated at Mouza – Dabgram, at Choto Phapri, Doodh Ghar, Near Baneshwar More, Police Station – Bhaktinagar, District – Jalpaiguri as fully described in the Schedule herein below, by virtue of a Deed of Sale executed by Sanat Chandra Roy and the said Deed was registered at the office of the Additional District sub-Registrar, Siliguri being No.I-1589 for the year 1995 and by virtue of the said purchase, he acquired the below schedule land in his khas, actual and physical possession having permanent, heritable and transferable right, title and interest therein.

After the above purchase, the name of my husband, Dr. Anup Kundu (since deceased) with regard to the below schedule land has been recorded in L.R.Khatian No.359 in part of L.R.Plot No.132 at Mouza – Dabgram, Police Station – Bhaktinagar (Rajganj), District – Jalpaiguri.

3. That my husband, Dr. Anup Kundu (since deceased) had been peacefully using, enjoying and occupying the below schedule land, on making payment of the Ground Rent (Khajna) to the Govt. of West Bengal regularly.
4. That being owner in such possession, my husband, Dr. Anup Kundu died on 17.05.2022, leaving behind me and one son, Sri Amartya Kundu and one daughter, Smt. Ananya Kundu as his only legal heirs and/or successors and thus we have jointly acquired the below schedule land in our khas, actual and physical possession, having permanent, heritable and transferable right, title and interest therein.
5. That I am now aged about 70 years. My son is now posted and residing in Hyderabad and my daughter is residing abroad and after the demise of my husband it was/is not possible for us to look after and manage our below schedule land and as such we engaged one of our relatives, Sri Anjan Paul Chowdhury, (Mobile No.9832331265), Son of Late R.P. Paul Chowdhury of Sanghati More, Siliguri, Police Station – Bhaktinagar, District – Jalpaiguri for looking after the said land.

6. That my said relative, Sri Anjan Paul Chowdhury, on 31.08.2024, during his visit of the below schedule land, found that some persons were constructing boundary wall on the eastern side of the below schedule land and he immediately raised objection and somehow restrained the said persons from doing the construction of the said wall.

7. That on 02.09.2024 at about 01:00 p.m. said Sri Anjan Paul Chowdhury against visited the below schedule land and at that time he found that the Mason disclosing his name as Sri Bikash Roy (Mobile No.8167062586) stated that he was doing the construction of the said boundary wall, under the instructions of one Sri Satya Narayan Goyal of Burdwan Road, Siliguri (Mobile No.9832375480) and one Sri Partha Singha Roy (Mobile No.8918682610).

8. That immediately said Sri Anjan Paul Chowdhury talked to Sri Satya Narayan Goyal over his said mobile no. and on being asked, he stated that he being the owner of the below schedule land was doing the construction of the said boundary wall. Then Sri Anjan Paul Chowdhury requested Sri Satya Narayan Goyal to come to the spot with his title deed, but he refused.

9. That ultimately, the strong resistance put forward by my said relative, Sri Anjan Paul Chowdhury, the construction of boundary wall was stopped, but after some time, Sri Partha Singha Roy threatened my relative, Sri Anjan Paul Chowdhury, stating that they would construct the boundary wall by any means and if he interferes in the construction of the wall, he would face the dire consequences.

10. That myself and my son and daughter are the lawful joint owners of the below schedule land and as we are living far away from the land, said Sri Satya Narayan Goyal, Sri Partha Singha Roy and their associates, with a malafide intention to grab our below schedule land, have been doing the said illegal activities in and around the below schedule land.

11. That I am a widow aged about 70 years and it is not possible for me to protect our below schedule land from the hands of the said miscreants and as such this complaint is lodged for the protection of our below schedule land.

You are, therefore, requested to enquire into the above matter and take immediate steps against Sri Satya Narayan Goyal, Sri Partha Singha Roy and their associates, so that we can save our land from the hands of the said miscreants and thereby oblige.
