In producing herewith the accused person namely Smt. Sabitri Thami, aged 50 yrs, w/o-Sambhu Thami, resident of Gumba Road, M.M. Terai, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Twelve (12) bottles of TUBORG Strong Premium Beer, each contains 650 ml @ Rs. 160/-, out of which one (01) bottle is taken out as sample and marked as Exhibit-A.

2. Twelve (12) bottles of KINGFISHER Imperial Strong Beer, each contains 650 ml @ Rs. 160/-, out of which one (01) bottle is taken out as sample and marked as Exhibit-B.

3. Five (05) bottles of EMBOSS Fine Whisky 50° UP India Made Liquor, each contains 750 ml @ Rs. 250/-, out of which one (01) bottle is taken out as sample and marked as Exhibit-C.

4. Twelve (12) bottles of Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs. 155/-, out of which one (01) bottle is taken out as sample and marked as Exhibit-D.

I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Smt. Sabitri Thami, aged 50 yrs, w/o-Sambhu Thami, resident of Gumba Road, M.M. Terai, PS- Bagdogra, Dist- Darjeeling to the effect that on 13.09.2024 at 11:35 hrs received reliable source information that a huge quantity of liquor is stored at the house cum restaurant of Smt. Sabitri Thami at Gumba Road, M.M. Terai under PS-Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and diarised the matter in GD vide Bagdogra PS GDE No. 621 dated 13.09.2024. Subsequently, as per direction I along with SI Samik Paul, ASI Amit Lama, ASI Munna Ahmed, VP/02 Pradip Roy, LCV/1025 Anila Singha, CV/375 Jogesh Barman, CV/386 Kishor Ranjan Howladar & CV/389 Janak Singh left for Gumba Road, M.M. Terai to work out the secret source information. This refers to Bagdogra PS GDE No. 622 dated 13.09.2024. At around 12:25 hrs we reached at Gumba Road, M.M. Terai and had been waiting for the source indication. After a while, the source indicated the house cum restaurant of the suspect Smt. Sabitri Thami and we proceeded to hold raid at the said house cum restaurant and managed to apprehend one female person there with the help of LCV/1025 Anila Singha and interrogated her. On interrogation, she revealed her identity as Smt. Sabitri Thami, aged 50 yrs, w/o- Sambhu Thami, resident of Gumba Road, M.M. Terai, PS- Bagdogra, Dist- Darjeeling (not verified) and she introduced herself as the owner of that house cum restaurant. We disclosed our identity to her and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely Asish Limboo (M/35 years), s/o- Late Jangi Prasad and Tanka Bahadur Gurung (M/55), s/o- Late Ashok Kumar Gurung, both are resident of M.M. Terai, PS- Bagdogra, Dist-Darjeeling were present as witness. Then, we conducted search at the said house cum restaurant in presence of the independent witnesses and the Police personnel. On search, the above noted liquor was recovered from the said house cum restaurant. On demand, she failed to produce any valid document/license for stocking and selling that liquor. She further confessed that she has been stocking and selling liquor illegally from her house cum restaurant for a long time for her wrongful gain. Accordingly, I seized that liquor under proper seizure list and at last, arrested the accused Smt. Sabitri Thami (as noted above) after observing all legal formalities and telling her the ground of arrest and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 12:40 hrs and 13:15 hrs on 13.09.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Smt. Sabitri Thami, aged 50 yrs, w/o- Sambhu Thami, resident of Gumba Road, M.M. Terai, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for
