I, Atri Sharma, son of Late Vaidya Nath Sharma, resident of Bhagwati Apartment-1, Shivmandir Road, Punjabi Para, P.O. Siliguri, P.S. Bhaktinagar, Pin: 734001, would like to lodge this written complaint against a reporter/anchor named Suddha Shil of "Priyo Bandhu Bangla Media" uploaded and circulated an offensive video against the Honorable Chief Justice of India in pertinence to the matter of R.G. Kar, which the Supreme Court took suo motu cognizance of. That the reporter/anchor as mentioned above prepared a report and circulated the contents through communicable devices that are very much offensive, defamatory, and menacing in character. Therefore, I request you to kindly acknowledge this written complaint, remove the content from social media, and take the necessary action against the aforementioned reporter/anchor.
