Respected Sir,

I the undersigned would like to draw your kind attention towards the fact that my father is the owner of a land measuring 0.665 acres appertaining to and forming part of R.S. Plot No. 681 and 675 and L.R. Plot No. 1468 and 1475 respectively recorded in L.R. Khatian No. 305 situated within Mouza - Binnaguri, J.L. No. 03, P.S: Bhaktinagar presently New Jalpaiguri Police Station, District: Jalpaiguri morefully described in the schedule herein below. Thereafter he mutated his name in the record of rights vide mutation case no. IX-II/73(F-2/03-04) and since then he is in peaceful possession of the said land and is exercising various rights as an owner over the said plot of land. That for last few days two persons namely Naresh Kumar Agarwal and Manoj Agarwal both are son of Late Motilal Agarwal and residents of C/o Sinhal Safe, Hill Cart Road, Near Sevoke More, Post Office and Police Station: Siliguri, District: Darjeeling, Pin Code: 734001 are trying to disturb my father's peaceful possession over the said land and tried to trespass illegally into the said land with the help of local goons. Thereafter my father filed a Civil Revisional Application before the Hon'ble High Court at Calcutta, Circuit Bench at Jalpaiguri being C.O. No. 138 of 2024. On 02.09.2024 the bench of Hon'ble Justice Rai Chattopadhyay was pleased to direct that the parties should maintain status quo as regards to their possession over the suit property and shall not change the nature and character thereof or alienate the same to any third party, till the next date, the matter is taken up by this Court.

The Accused Persons along with their agents came to the said land on 12.09.2024 at around 10pm and trying to occupy and illegally trespass my father's land and is threaten my caretakers namely 1. Satip Mahammad, Son of Assarunddin, and 2. Ayub Mohammad, Son of Satibulla Mohammad, both are resident of Chhat Pradhanpara, Binnaguri, Bhaktinagar, Jalpaiguri - 734015.

It is my humble request before your kind office that my father have every right to protect his piece of land and thereby enjoy the peaceful possession and the same is guaranteed by way of Article 300A of the Constitution of India and my father should not be deprived of his

peaceful enjoyment over the said land by the illegal acts of the hooligans.

I being a law abiding citizen is making this prayer before your kind office to the effect that my constitutional rights with respect to the property is not curtailed in any manner whatsoever and affective steps in this regards may be taken by the police authorities to protect my father's peaceful possession over the said piece of land.
