Respected Sir/Madam,

I SRI NARESH KUMAR AGARWAL resident of 14A Sai Marg, Asha Purna Sarani, Siliguri, P.O. & P.S. Pradhan Nagar -734003 in the District of Darjeeling, would like to lodge a complaint stating the following facts:

1. That today i.e. on 13.09.2024 at around 10:00 am when I was at my factory situated behind Narayana School at Jotiakati, Fulbari, I came to know that a mob of around 30 to 40 persons have gathered near our joint family land situated near Nirmal Trucks, at Fulbari-Jotiakali Highway Road, which is near my factory.
It is pertinent to mention here that the joint family land is a subject matter of a Partition suit between the family members before the Ld. Court at Siliguri.
2. That after getting the information of the mob gathered near our land, I along with my son Aman Agarwal immediately left for the said joint family land.
3. That after reaching the site I got to see a huge mob of around 40 people surrounding our land carrying bamboo sticks, rods etc and headed by one **Abhishek Garg** S/o Shyam Garg (M-82506-50742) Resident of Green Vista Apartment, Sevoke Road Siliguri, along with local goons namely Md. Safikul (M-80162-95333), Md. Ayub S/o Md Safikul, Shekhim Haque (M-70748-59688) among others are trying to enter into our land.
4. That after confronting them regarding their intention, the abovenamed Abhishek Garg started insulting me and started hurling abuses at me. That the said Abhishek Garg then pushed his hand towards me and hit me at my chest and after getting hit, I fell down, then he took a bamboo stick and was about to hit me at my head with an intention to kill me which my son blocked with his hand, that this didn't stop him from hitting me again, I immediately got up and started running along with my son.
5. That after running to safety I got to see that Shankar Lal Agarwal and his son Ayush Agarwal were standing away from the said land and instructing the mob to run behind us and kill us.
It is worthy to note here that the said Shankar Lal Agarwal is a party in the said Partition suit as mentioned above.
6. That somehow a police van arrived at the incident site and seeing the same, entire mob ran away and I got a sigh of relief.
7. I am currently in a state of fear that abovementioned Abhishek Garg who threatened me with dire consequences would try to attack and assault me again.
8. That as it is my daily routine to go to my factory by passing the said joint family land, I am in dilemma that they would again hatch a plan to assault me and kill me and having no other alternative, I have come to your asylum for support and help.
9. Therefore I request your honoured self to take necessary action against the said miscreants and help me save my and my family members life from the abovementioned miscreants and the said joint family land from being encroached by the said miscreants.
