Sir,

In producing here with one arrested accused person namely Niresh Ch Shil (45) S/o Lt. Rajendra Nath Shil of Dharamganj, W.No. 11, PS- Kishanganj ( Nagar Parishad) Dist. Kishanganj, Bihar and seized 01 (one) Truck having registration No. WB-59-A-4615 loaded with river bed materials i.e. stone chips as per proper seizure list.

In this regards I SI Kazi Rejaul Karim of New Jalpaiguri PS , SPC lodged a written complaint against the above noted arrested accused person to the effect that on 13.09.24 myself alongwith force, C/ 679 Masud Alam, C/1035 Sontosh Rabi Das, NVF-65 Prakash Roy and NVF-192 Chandan Roy alongwith force were performing evening mobile duty and at 18-55 hrs received source information that some loaded vehicles were seen with carrying riverbed materials i.e. stone chips illegally from jalpaiguri side to Siliguri side. Accordingly I informed the matter to the O.C. NJP PS and also duty officer of PS and noted in GD vide NJP PS GDE No. 684 dt. 13.09.24. At 19-25 hrs. As per direction myself alongwith force reached near Tinbatti More and at 19-45 hrs found that the above noted vehicle loaded with stone chips was coming from Jalpaiguri side towards Noukaghat, Siliguri. I alongwith force detained the said vehicle at near Tinbatti More under PS NJP and apprehended the driver of the said vehicle, on asked he disclosed his name and address mentioned above and found that the said vehicle was loaded with stone chips (riverbed materials). On demand the driver of said vehicle failed to produce any documents/papers in favour of the carried substances (stone chips) and also failed to produce papers in support of the said vehicle. During enquiry it could be ascertained that the riverbed materials were loaded from kortowa river at Ambari , Jalpaiguri for Kishanganj illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the above noted vehicle loaded with stone chips with a proper seizure list and arrested the driver of the said vehicle u/s 35 BNSS after maintaining all formalities of law. The seizure and arrest was done in between 19-55 hrs to 20-15 hrs.

Under the above circumstances I pray that a specific case may kind be started against the arrested person namely Niresh Ch Shil (45) S/o Lt. Rajendra Nath Shil of Dharamganj, W.No. 11, PS- Kishanganj (Nagar Parishad) Dist. Kishanganj, Bihar and arranged for its investigation .
