This is to bring to your kind notice that I, NilmoniMaji, son of- NitaiMaji, resident of Rabindra Nagar, Ward No. 21 of Siliguri Municipal Corporation, Siliguri, Post Office- Rabindra Saran Police Station- Siliguri, District- Darjeeling, would like to inform you that I am an Assistant Cive Engineer working under the Government of West Bengal and I am a reputed and well respected person my locality as well as in my work place.

It is to mention here that for the past one and a half years I have been incessantly receivir calls in my phone (my phone number- 8420735798 and 8509461749) from some unknown number which are- (9330317763, 8240558942, 8276965866, 8618768944, 8918933244, 833601310 7044523836, 8336862523, 6289219293, 9641286399, 8336862523 and 6289219293), wherein the unknown callers have threatened me over the phone stating that they will make false dirty videos with my face on it and not only release them over the internet but also send them to my wife and regist false cases against me if I don't pay those people the money demanded by them. I being a Governme employee, out of fear of losing my job and my image in society, paid Rs. 17,37,488/- (Rupe Seventeen Lakhs thirty-seven thousand four hundred and eighty-eight only) from 10.05.2023 to 15.02.2024 on several occasions as per their demand from various accounts (including from my colleague's accounts) which are as follows-

That on 02.07.2024, I have registered a formal complaint with the Cyber Crime P.S., S.P.C which was registered as G.D.E. No. 35, with the subject- Blackmailing over phone and demand f money. The Officer-in-Charge advised me to change my phone number and also assured me that will take strict actions against those notorious people, but till date no action has been taken again those notorious people. Upon suchadvice, I changed my phone number from 8420735798 8509461749 and even after changing my number, my number was again somehow leaked to the notorious people and they again started disturbing my peaceful life and is incessantly threatening as blackmailing me to give them money.

It is also to mention here that one person named BikashBhagat, resident of-Karimpur, District-Nadia, along with another person namely- S. Mauryawho identified himself as a DSP, called me from 8336862523 and assured me that if I pay Rs. 10,00,000/- (Rupees Ten Lakhs only) to him, then he will make sure that I do not get any threat calls and that no false case is registered in my name and even if any case is registered, he will personally handle those matters as he has very good connection with the police all over the country. I being a layman, out of fear and believing in his statements, paid the said amount to him. After making such payment, the threat calls increased, and those notorious people have not only contacted me from various unknown phone numbers but also in me and my wife'sfacebook account. From various unknown profiles I am receiving threat messages, and one such profile is of Angel Anamika.

That it is pertinent to mention here that under the aforesaid facts and circumstances, my marita life as well as my professional life has been heavily disturbed due to such threat calls. In such situation, I hereby request you to kindly find out the aforesaid persons, whose phone numbers and facebook profiles have been mentioned hereinabove and take strict actions against those persons an all the persons involved in such offence either directly or indirectly and to punish them as per th provisions of law.
