Siliguri, & (3) Gaurab Kumar (22) S/o Sri Sakaldd
Mishra, of Tyotinagar Colony (Near Shab Mandar)
Ward No. 4 SMC, P.O. & P.S. Siliguri, Distt. - Darjeeling,
were returning to their house and saw a person
Puchkawala namely, Pradeep S/o Not known of
Tyotinagar colony (Near Shab Mandar) Ward no 4
P.O. & P.S. Siliguri, near 4th Mahananda Bridge,
and stopped that Puchka Thela (Cart) there
and started having Puchka, at that time &
place, one Dilip Das S/o Lt. Prantandher Das
of Tyotinagar colony (Near 4th Mahananda Bridge)
Ward No. 4 SMC, P.O. & P.S. Siliguri, Distt. - Darjeeling,
suddenly attacked on my said son namely, Ranjit
Yadav, with a knife and he received deep
long cut from chest to his abdomen, and heavy
bleeding started from his body and his above
noted friends namely Ramesh Singh & Gaurab
Kumar, immediately shifted my son to Siliguri
Distt. Hospital & admitted him there in serious
condition, & fighting with his life & death.

So, please take necessary action against
Dilip Das S/o Lt. Prantandher Das of Tyotinaga
Colony (Near 4th Mahananda Bridge) Ward no.
P.O. & P.S. Siliguri, for attempt to murder my
