
Respected Sir,

I, Dhananjay Kumar Gupta, aged about 37 Years, Son of Mr. Nand Lal Gupta, resident of Vidyasagarpally, Ghoshpara, Post Office and Police Station-Siliguri, District-Darjeeling, would like to lodge this complaint stating inter-alia, that on 04/09/2024 at about 10:30 P.M, when I was passing by from Bidhan Road towards Hakimpara, (Near Amrit Sweets) the rider of the above mentioned two wheeler vehicle/Motorcycle in very high speed coming from Siliguri Venus more going towards Panitankimore, that too in wrong side i.e riding the two wheeler vehicle/Motorcycle in very rash and negligently from right side in excessive speed hit my two wheeler vehicle/motorcycle. The moment the two wheeler vehicle/motorcycle WB70R1130 dashed my two wheeler vehicle/motorcycle WB74BN5273, I fell down from my two wheeler vehicle/motorcycle and sustain serious injuries on my persona. That since then I am in complete bed rest and even could not attend nature's call. My entire life spent on Bed only. The said accident has badly effect my future life, which could be seen from the medical reports. It is right place to mention here that delay in lodging this complaint is due to my health conditions. I am still on stretcher and moving with the help of others only.

This is my humble request please take necessary action against the accused person and also release my two wheeler vehicle/motorcycle WB74BN5273.
