Sir,

In producing herewith 04 (Four) arrested accused persons namely (1) Dipak Kahar-21yrs S/O Lt. Surinder Kahar of Koila Dipo, Ward No-07, PS Siliguri, Dist. Darjeeling (2) Biki Nag-24yrs S/O- Nanadalal Nag of Durga Nagar, W/No- 40, PS-Bhaktinagar, Dist. Jalpaiguri (3) Rahul Chhetri-24yrs s/o Lt. Manoj Chhetri of Salugara near pipeline, PS- Bhaktinagar, Dist. Jalpaiguri and (4) Kalu Tamang (38 yrs S/O- Lt. Kumar Tamang of Salugara, Durga mandir, PS- Bhaktinagar, Dist. Jalpaiguri arrested on 16.09.24 u/s- 35(1) of BNSS along with following seized articles viz: -

- 1. One iron rod measuring about 21 inch (approx) from the possession of accused Dipak Kahar which was kept in his right hand.
- 2. One iron rod measuring about 22 inch (approx) from the possession of accused Biki Nag which was kept in his right hand.
- 3. One iron-made saw with a rubber butt measuring about 14 inch (approx) from the possession of accused Rahul Chhetri which was kept in his right hand.
- 4. One rope measuring about 20 feet (approx) from the possession of accused Kalu Tamang which was kept in his right hand.

I, PSI Koushik Raha S/O- Jitendra Raha of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons and others to the effect that, on 16.09.24 at 01.05 hrs received a source's information that 7/8 persons have assembled at Lal Mohan Ghat near Kumartully under Siliguri PS for preparing to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No 784 Dated 16.09.24 Subsequently after sharing the information with I/C PS and as per his direction, at 01 15 hrs myself along with SI Uday Chakraborty, ASI Debasish Das, ASI Subir Sen, C/160 Soumen Sarkar, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with kits left for the place to work out the information. This refers to Siliguri PS GDE No-785 dated 16.09.24.

We reached at PO at 01.25 hrs on 16.09.24 and waiting there, subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from that Place. Sensing the police had cordoned off, they tried to flee away but on hot chase, we managed to apprehend the above-noted 04 (Four) accused persons along with seized articles as mentioned above. However, the other 3/4 persons managed to flee away from the spot taking advantage of the darkness. On interrogation, the accused persons admitted that they had assembled there to commit dacoity in a house in Siliguri PS area. They also stated that one Md. Sahajahan, MD Kalam, and three others fled away from the spot.

I thereafter, seized the above-noted weapons under the proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made on 16.07.24 in between 01.35 hrs to 02.05 hrs) Thereafter, I arrested the above-noted accused persons u/s 35 (1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied a copy of arrest memo to them. The process of search & seizure has been audio & video graphed at the PO.

I accordingly, brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During interrogation, they stated that they were gathered there to commit Dacoity in a house in Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above-noted accused persons viz. (1) Dipak Kahar-21yrs S/O Lt. Surinder Kahar of Koila Dipo, Ward No-07, PS Siliguri, Dist. Darjeeling (2) Biki Nag-24yrs S/O- Nanadalal Nag of Durga Nagar, W/No-40, PS-Bhaktinagar, Dist. Jalpaiguri (3) Rahul Chhetri-24yrs s/o Lt. Manoj Chhetri of Salugara near pipeline, PS- Bhaktinagar, Dist. Jalpaiguri and (4) Kalu Tamang (38 yrs)S/O- Lt. Kumar Tamang of Salugara, Durga mandir, PS- Bhaktinagar, Dist Jalpaiguri and Md. Sahajahan, MD Kalam and three/ four others and arrange for its investigation.
