I Smt. Khusboo Sah (Mob: 8617083449) wife of Ranjit Kumar Sah, resident of Gurung Basti, Durga Nagar Colony, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, would like to inform you the following facts:-

1. That on 13.09.2024 at about 10.30 P.M. there is a place near of my house where some persons namely (i) Gouri Shankar Ram son of Unknown, (ii) Suraj Ram son of Gouri Shankar Ram, (iii) Akash Ram son of Gouri Shankar Ram, (iv) Ayush Ram son of Gouri Shankar Ram, (v) Rohit Mahato son of Mangal Mahato and 4 to 5 persons their associates all are resident of Gurung Basti, Durga Nagar Colony, Sharma Patty, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, are started to create nuisance and when I along with my husband went to stop them from disturbing and make noise, One Akash Ram son of Gouri Shankar Ram and their associates (Goons) suddenly Physically assaulted me and my husband Ranjit Kumar Sah son of Late Upendra Sah and brutally attacked with fists and blows and by lathi, Iron rod and leather belt got head injury with blooded in front of my house at Gurung Basti, Durga Nagar Colony, Sharma Patty, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling.

After that on that time my Brother in -law namely Dinesh Sah son of Late Upendra Sah came to the incident to stop them, (i) Gauri Shankar Ram, (ii) Suraj Ram, (iii) Aayush Ram, (iv) Rohit Mahato and their all associates Physically assaulted on his head with wooden buttam with blooded and then they also physically assaulted me with their wrong intension and touched my body parts use of criminal force with intent to disrobe and outrage my modesty after that anyhow I tried to save them

from their hands and I took them to the Siliguri District Hospital, Siliguri, Dist. Darjeeling.

- That my husband and my brother in law were got serious injury on their heads, got 1 stitches on his head, and 1 to 3 stitches on his head and whole body swelling, now they are got very serious injury.
- 3. That due to such assault upon me and my aforesaid husband and brother in law and due to their such attempt to murder of my said husband and brother in law in such cruel manners, they sustained severe injuries on their persons and they were medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 13.09.2024 at about 11.00 P.M. and still they are under medical treatment.
- 4. That due to serious injury caused due to such assaulted by them upon my aforesaid husband and brother in law and me delay is caused for lodging this F.I.R. which may kindly be condoned.
- 5. That the Xerox copies of medical treatments papers are enclosed here with.

I therefore request you to kindly take necessary steps against the aforesaid culprits for the commission of the aforesaid offences upon my aforesaid husband and brother in- law and me.
