In producing herewith one (01) arrested person who disclosed his identity as (1) Ram Krishna (M/41 yrs), S/O- Lt. Jay Prakash Sharma of Bholanath Para, Dabgram, PS- NJP, Dist Jalpaiguri Permanent address Vill+PO- Amhara, PS- Bihta, Dist. Patna, Bihar (Not verified) along with the following seized articles, seized under proper seizure list, duly attached herewith viz:

- (1) One white colour plastic handbag containing 100 (One Hundred) bottles of "Chlorpheniramine Maleate & Codeine Phosphate Cough Linctus" PHENSEDYL cough syrup each bottle containing 100 ML having batch no PHC22002, Mfg. date- MAY 22, Expiry date OCT 23, total quantity 100ml X 100 = 10,000 ML/ 10 litres and marked as Exhibit- A.
- (2) One Samsung mobile having IMEI (I)- 358107170009964/01 IMEI (II) 358419750009961/01 and marked as Exhibit- B

I, PSI Koushik Raha, S/O- Jitendra Raha of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against one (1) Ram Krishna (M/41 yrs); S/O Lt Jay Prakash Sharma of Bholanath Para, Dabgram, PS- NJP, Dist Jalpaiguri Permanent address Vill+PQ- Amhara, PS- Bihta, Dist. Patna, Bihar (Not verified) to the effect that today i.e. on 19 09.24 at 14.15 hrs I have received a specific reliable source information that one person intentionally standing with a huge quantity of expiry Cough Syrup at P&T goli, Milanpally to sell his design customer for his wrongful gain. The matter has been diarized vide Siliguri PS GDE, No.980 Dt- 19.09.24. Accordingly, I informed the matter to Sri Prasenjit Biswas, Inspector in Charge, Siliguri Police Station, SPC in writing a letter to him and expressed the entire information. Accordingly, he directed to me to work out the information immediately. Hence at about 14.35 hrs as per his kind direction myself along with SI Uday Chakraborty, ASI Debasishi Das, ASI Rabin Lama, ASI Subir Sen, ASI Sanjay Basunia, C/160 Soumen Sarkar, C/1402 Sonet Barua all of Siliguri Police Station, Siliguri Police Commissionerate left for Milanpally area to verify the veracity of the information vide M.C.C. No. 671/24 Dt. 19.09.24 which refers to GDE. No.981 Dt. 19.09.24 by Govt. Vehicle No. WB-77-4887 driven by CV/285 Krishna Yaday.

At the time of departure from PS, I took an envelope, white paper, sealing wax gum seal Digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 14.45 hrs we reached at nearby P&T goli, Milanpally & kept our vehicles at a distance. Subsequently, we called two independent witnesses namely; I) Suraj Yadav 25yrs s/o Binod Yadav of Santoshi nagar, W/No-05, PS- Siliguri, Dist. Darjeeling (Ph-6294065097) and (2) Ashok Sikdar 52yrs s/o Lt. Hari Kunj Sikdar of P&T Goli, New Milanpally, W/No- 25, PS- Siliguri, Dist. Darjeeling and disclosed our identities and informed them about the information in hand and requested them in writing to accompany us to witness the Police action. They agreed & gave in writing about their consent to accompany Police during the raid.

Then, as per source information, we approached towards P& T Goli, Milanpally & as per identification by source I managed to cordon the place and found that the above-noted person carrying a white colour bag with an intension to sell the above-noted contraband Cough Syrup Accordingly, we detained the above noted person.

After disclosing our identities, in the presence of independent witnesses, we had a strong reason to believe that the detained person intentionally was carrying the expiry contraband Cough Syrup in his exclusive and conscious possession & trying to supplying/ selling the same in the area for his wrongful gain. On being asked he disclosed his identity as noted above and admitted that he possessed the expiry Cough Syrup. Then I gave him option in written whether he wanted to be searched in presence of Executive Magistrate or any Gazetted Police Officer. He agreed to be searched by one of them. Further, I served him option notice in accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one of them in writing on the notice served to him.

Then I informed the matter to I.C. Siliguri PS to present at P&T goli, Milanpally, W/no-25 PS- Siliguri, Dist. Darjeeling for the search and seizure. Accordingly, at 15:15 hrs Sri Prasenjit Biswas, I. C. Siliguri PS along with Shri, Tridib Sarkar ACP East-I SPC arrived at the spot in uniform and disclosed their identity to the detained person as well as to the witnesses as a Gazetted Police Officer. I also offered the independent witnesses and the accused person to search our Police Party as per the provision of law. But they refused to search the police party Under the supervision of Shri, Tridib Sarkar ACP East-I SPC & Sri Prasenjit Biswas, Inspector In-charge, of Siliguri Police Station, SPC and in presence of two independent and dis-interested public witnesses, I therefore searched the detained person following all formalities keeping his decency and recovered above noted mobile phone from his possession. Then, I opened the white colour plastic bag and found that the above seizure articles kept in the said bag. Then the detained person confessed that he was carrying this expiry contraband cough syrup intentionally for selling/supplying to young boys under Siliguri and its adjacent area. On demand, in presence of the Gazetted Police Officer, Shri, Tridib Sarkar ACP East-I SPC & Sri Prasenjit Biswas, Inspector -In-charge, of Siliguri Police Station, SPC, he failed to produce any valid document in support of possessing of the said contraband expiry Cough Syrup bag which was holding by him

Accordingly, I counted the said bag containing Cough Syrup, which was found in possession of the above-noted detained person and found total 100 (One Hundred) bottles of cough syrup each bottle containing 100 ML having batch no PHC22002, Mfg. date- MAY 22, Expiry date OCT 23, total quantity 100ml X 100 = 10,000 ML/ 10 litres and marked as Exhibit-A, and (ii) One Samsung mobile having IMEI (I)- 358107170009964/01 IMEI (II) 358419750009961/01 marked as Exhibit- B. Then, I seized the above-noted articles under proper seizure list and labeled, duly signed by the above-noted witnesses, Police personnel and the Gazetted Police Officer and duly acknowledge by the detained person. I also supplied a copy of seizure list to the detained person. The whole search, seizure & label was made in between 15.25 hrs and 16.55 hrs. On further asked the apprehended person confessed in presence of Gazetted Police Officer, Shri, Tridib Sarkar ACP East-I SPC & Sri Prasenjit Biswas, Inspector -Incharge, of Siliguri Police Station, SPC, and other witnesses that he procured the said seized expiry Cough Syrup for the purpose of illicit gain. On interrogation, he disclosed that he used to dealing such type of expiry cough syrup illegally since long. The whole process of search and seizure was video graphed by Photographer Somnath Chatterjee (41 yrs) S/O- Sushil Chatterjee of Arabinda Pally, W/N- 22 PS Siliguri Dist Darjeeling. Then I arrested the above-noted accused person after observing all guidelines of Apex court.

Under the above circumstances, I pray to you that a specific case under the proper section of law may kindly be started against the accused person namely (1) Ram Krishna (M/41 yrs), S/O- Lt. Jay Prakashi Sharma of Bholanath Para, Dabgram, PS- NJP, Dist. Jalpaiguri Permanent address Vill+PO- Amhara, PS- Bihta, Dist. Patna, Bihar.
