Respected Sir,

I the above-named, would like to state that Bikash Chowdhury (since deceased) is/was my childhood friend who was inducted as tenant in respect of shop room situated Ranindra Nagar More, Ward No. 21 of S.M.C by Balahari Das (since deceased). That my said friend died on 21.07.2019 and since then the tenanted premises is/was used by his wife Smt. Chandana Chowdhury with the help of his brother Prakash Chowdhury to earn their bread and butter to feed their family which is/was their only source of income.

That I was sharing a cordial relation with my said friend and his family members and after his death I always supported his family in their ups and down.

It is pertinent to mention here that till said Balahari Das was alive said Chandana Chowdhury were enjoying and possessing the said rented premises peacefully and without any hindrances from any person whatsoever but after

the sudden death of said Balahari Das in August, 2023 his legal heirs particularly his younger son Uttam Das, his elder deceased son's wife Manami Das, his younger daughter Baby Das started creating chaos and deliberately trying to disposes them from the said rented premises by any means and threatened with dire consequences to quit and vacate the same. That as I closely associate with Prakash Chowdhury and said Chandana Chowdhury I always stood by their side in wrong had happen to them.

It is pertinent to mention here that the disputes and differences in respect of rented premises between Chandana Chowdhury and Uttam Das & Ors. increased to such extent that said Chandana Chowdhury has filed a suit against them on 21.05.2024 before the Ld. Civil Judge [Jr. Division], Siliguri, being T.S. No. 92 of 2024 against Uttam Das & Ors., and after hearing the 'interim application' injunction order has been passed in favour of the Chandana Chowdhury. That as I am sharing a cordial relationship with them the above-named miscreants think that with my help they filed the said suit as such number of time they threatened me to make understand to said 'Chandana Chowdhury' to withdraw the said suit. That on 18.09.2024 at about 11.30 p.m. when I was going my home while crossing the Rabindra Nagar More the daughter of Manami Das namely Juhi Das suddenly appeared before me at Rabindra Nagar More and threatened to keep distance in the matter of their family and said Chandana Chowdhury but when I express my desire that I do not want to talk into this matter she abused me in filthy languages and threatened me to implicate me in criminal case as such to save my reputation I went away. That today at about 10.30 p.m. when I open my shop situated at Rabindra Nagar More the above-named miscreants came to my shop and started to pass filthy languages and threatened me with dire consequences to close my shop and on my protest Indu Biswas the daughter-in-law of Baby Das suddenly slapped me twice in my left face. That thereafter Raja Das, Uttam Das, Manami Das, Baby Das, Mita Das, Juhi Das and Indu Biswas has

assaulted me with fist and blows and further threatened me that today onwards if I open my said premises they will kill me.

That said Raja Das, Uttam Das, Manami Das, Baby Das, Mita Das, Juhi Das and Indu Biswas are leaving no stone unturned to disturb me since the day said Chandana Chowdhury has instituted the said suit against them.

Under the above circumstances I lodged this complaint against Raja Das, Uttam Das, Manami Das, Baby Das, Mita Das, Juhi Das and Indu Biswas, all resident of Rabindra Nagar More, ward no. 21 of S.M.C, Post Office Rabindra Sarani, Police Station Siliguri, District Darjeeling and would like to request you to look into the matter and take immediate step against the said miscreants as per the procedure established by law.
