Subject: FIR

Sir,

In producing herewith 03 (Three) arrested accused persons namely (1) Niki Das-20yrs S/O Lt.Jaganath Dasof Thakkar, Diesel Colony, Ward No-01, PS-Pradhan Nagar, Dist. Darjeeling (2) Paban Kumar Singh-31yrs S/O-Promod Singh of Jyotinagar, W/No-04, PS- Siliguri, Dist. Darjeeling (3) Ajay Barman-20 yrs s/o Lt. Goutam Barman of Koila Dipo, W/no- 07,PS- Siliguri, Dist. Darjeeling arrested on 20.09.24 u/s- 35(1) of BNSS along with following seized articles viz: -

1. One iron-made knife with a wooden butt measuring about 11inch (approx) from the possession of accused Niki Das which was kept in his right hand.
2. One iron-made crowbar measuring about 18 inches (approx) from the possession of accused Paban Kumar Singh kept in his right hand.
3. One iron-made crowbar measuring about 12 inch (approx) from the possession of accused Ajay Barman which was kept in his right hand.

I, SI Uday Chakraborty S/O-Lt. Samir Chakraborty of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons and others to the effect that, on 20.09.24 at 01.10 hrs received a secret source's information that 09/10 persons have assembled at Arabinda Bidya Mandir Ground Tikiapara near Hanuman Mandir under Siliguri PS for preparing to commit dacoity in a house at Babupara area under Siliguri PS . The fact was diarized in G.D vide Siliguri PS GDE No.1013 Dated 20.09.24 Subsequently after sharing the information with I/C PS and as per his direction, at 00.15hrs myself along with PSI Koushik Raha, ASI Debasish Das, ASI Subir Sen, C/160 Soumen Sarkar, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with investigation kits left for the the above noted place to work out the information. This refers to Siliguri PS GDE No. 1014 dated 20.09.24.

We reached at PO at 01.25 hrs on 20.09.24 and waiting there, subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from that Place. Sensing the police had cordoned off, they tried to flee away but on hot chase, we managed to apprehend the above-noted 03 (Three) accused persons along with seized articles as mentioned above. However, the other 6/7 persons managed to flee away from the spot taking advantage of the darkness. On interrogation, the accused persons admitted that they had assembled there to commit dacoity in a house at Babupara area under in Siliguri PS. They also stated that one Md. Sahajahan, MD Kalam, and others fled away from the spot.

I thereafter, seized the above-noted weapons under the proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole search & seizure was made on 20.09.24 in between 01.45hrs to 02.55hrs) Thereafter, I arrested the above-noted accused persons u/s 35 (1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied a copy of arrest memo to them. The process of search & seizure has been audio & video graphed at the PO.

I accordingly, brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During interrogation, they stated that they were gathered there to commit Dacoity in a house at Babupara area under Siliguri PS area.
