I Parveen Dhaakar, s/o G. Umesh Dhaakar, shop situated at near Central Bank, beside Prince Hotel, P.O. Bhaktinagar, P.S. N.J.P, Dist. Talpurgum, would like to state you that I alongwith my brother Bijay Dhaakar running a shop at the address mentioned above. On 15.09.2024 at about 10.22 p.m. three persons, one of whom named 'Chotu' & others two, name not known but all of whom are the resident of Raja Hauli, by occupation are drivers came at my shop & without any reason started to assault me with knife & belt as a result of which I sustained grave injury in back of my scalp & when my brother 'Bijay Dhaakar' try to stop in their said act they also assaulted him in his chin just below of his left eye as such he also sustain injury & both of us was in pain and during such situation they stole away a sum of Rs. 10,000/- from the cash box of my shop.

Under such constrained circumstances I lodging this complaint against 'Chotu' & two others who are the resident of Raja Hauli, P.S. N.J.P, Dist. Talpurgum and all are the driver by profession working in N.J.P, & would request you to arrest the culprit as soon as possible.
