

In producing herewith the accused person namely Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist.- Darjeeling under arrest along with the following articles under proper seizure:- (i) One black colour backpack styled as "Puma" with three compartments containing 30 (thirty) bottles of Codeine Phosphate & Triprolidine Hydrochloride syrup "REXLEY-T", cough syrup, each bottle containing 100 ml i.e.. total (30 x 100 ml) = 3000 ml, having batch No. ML-5778, Mfg date 03/24, Exp date 02/26, and each bottle MRP Rs. 175.00 marked as Exhibit "A". In this regard I, SI Bandhan Roy, S/O Nanda Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against above noted arrested accused person namely Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 21.09.2024 at 14.15 hrs I, received a reliable specific secret source input that one person possessing and carrying huge quantity of illegal contraband without any valid license would come to Dagapur Tea Garden under Pradhan Nagar PS, Dist.- Darjeeling to deliver the same to his designed customers and there were strong reason to believe the source input.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1244 dated 21.09.24 and I informed the matter to you in writing. Subsequently, being directed by you, at about 14.25 hrs I along with SI Goutam Mallik, SI Bhiswadeb Barman, ASI Biplab Kr Das, C/1198 Rajesh Kumar and C/1415 Chandan Basak all of Pradhan Nagar PS, SPC left for Dagapur Tea Garden along with investigation kits and without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 1245 dated 21.09.2024 and M.C.C. No. 802/24 dated 21.09.2024. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and requested him to come to Dagapur Tea Garden with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed and briefed them properly.

At about 14.45 hrs, I along with the above mentioned officers and force reached at Dagapur Tea Garden under Pradhan Nagar PS and contacted my source who stated that the person possessing illegal cough syrup would come to Dagapur Tea Garden shortly to deliver the same to his designed customers. Then, I requested two available independent persons namely (i) Gaffar Islam (45 yrs), S/O Late Md. Masiruddin of Sukna Tea Estate, Factory Line, PO+PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Helarus Kujur (39 yrs), S/O Late Banipas Kujur of Khaprijote, Sukna Tea Estate, PS- Pradhan Nagar, Dist.- Darjeeling and shared the information with them in writing to remain present and act as witness if any search and seizure would be made upon which they agreed. At around 15.25 hrs as identified by the source, I noticed that one person having one black colour backpack on his back was coming from the side of main road and proceeding towards Dagapur Tea Garden side. Accordingly, we managed to detain the said person at Dagapur Tea Garden with a black colour back pack in his possession. Thereafter, we disclosed our identities as Police personnel (as I along with 2/3 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS-Pradhan Nagar, Dist- Darjeeling. Then, I issued notice in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer which he agreed to be searched in presence of any of one of the noted above.

Accordingly, I informed the matter to you over mobile phone and requested you to inform or send message to the SDO, Siliguri to depute an Executive Magistrate to come to the detention place at Dagapur Tea Garden under Pradhan Nagar PS, Dist.- Darjeeling. Accordingly, at 15.46 hrs, you arranged to send a message to the SDO, Siliguri with a request to depute one Executive Magistrate to supervise the entire process of search and seizure vide Pradhan Nagar PS ORG No. 3408/24 dated 21.09.24. At around 17.05 hrs the above mentioned videographer namely Somnath Chatterjee came to the spot at Dagapur Tea Garden and accordingly, I issued a notice to him for video graph of the entire process of search and seizure. At around 17.15 hrs I, received phone call from you that SDO, Siliguri made no response over the e mail for detailing of an Executive Magistrate for the purpose search of the suspect and seizure of the contraband articles if found. Then at around 17.45 hrs you arrived at the spot at Dagapur Tea Garden under PS- Pradhan Nagar, Dist.- Darjeeling to perform the duty of a gazetted officer being the I/C of Pradhan Nagar PS. Then on camera, I offered the independent witnesses and the detained person to search our Police Personnel as per provisions of law but they denied searching of the Police personnel.



Thereafter, in presence of you and independent witnesses noted above, I searched the detained person following all formalities, maintaining the strict regard of decency but found nothing except his wearing apparels but on search of the black colour back pack styled as "Puma" under the possession of the accused Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist.- Darjeeling recovered 30 (thirty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride syrup "REXLEY-T" cough syrup, each bottle containing 100 ml, i.e. total (30 x 100 ml) = 3000 ml having batch No. ML-5778, Mfg date 03/24, Exp date 02/26, each bottle MRP Rs. 175.00. On demand in presence of you and independent witnesses, the detained person namely Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist.- Darjeeling failed to produce any valid document/paper for possessing or selling such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his designed and selected customers and also stated that he came there for the purpose of his such type of illegal business of procuring and selling "Codeine Phosphate based Cough Syrup" illegally for the last few months for his wrongful gain.

Accordingly, I seized the said articles viz: One black colour back pack styled as "Puma" with three Compartments containing 30 (thirty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride syrup "REXLEY-T", cough syrup, each bottle containing 100 ml i.e. total (30 x 100 ml) = 3000 ml, having batch No ML-5778, Mfg date 03/24, Exp date 02/26, each bottle MRP Rs. 175.00 marked as Exhibit "A" under proper seizure list from the possession of accused person namely Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist.- Darjeeling in presence of you and independent witnesses and obtained their signatures which are acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused person from the spot. The whole process of search, seizure and labelling were made under the coverage of video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 18.05 hrs to 18.45 hrs. From the above noted facts and seizure of incriminating articles, it is quite evident that the accused person namely Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist. Darjeeling is involved in procuring and selling "Codeine Phosphate Cough Syrup" illegally contravening the regulations of NDPS Act. Then, I arrested him after observing all formalities, informing him regarding the ground of his arrest and issuing a copy of Memo of Arrest to him. I also informed the guardian of the arrested person regarding his arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the accused person namely Samir Raha (30 yrs), S/O Late Sudhir Raha of Champasari Anchal, Dhaknikata, PS- Pradhan Nagar, Dist.- Darjeeling and its investigation may kindly be arranged.
