Sir,

I, Anugraha Behera, Son of Late Nutan Chandra Behera, resident of Ward No. 46 of SMC, Champasari, P.S. Pradhannagar, District Darjeeling, do hereby like to complain before you as follows :

1. That I am working as Marketing Head and Technical in SRILOK POLYPLAST PVT. LTD., situated at P.B.R. Tower, 2nd Floor, S/12, P.S. Bhaktinagar, District Jalpaiguri.
2. That on 20.09.2024 at about 6.00 P.m. the Director of the company called me in my office as mentioned above.
3. That when I reached there the Directors of my company namely (a) Rajat Khenkar, (b) Yash Agarwal, Son of Rajesh Agarwal and (c) Rakesh Agarwal started to abuse me with filthy languages and suddenly forced to me to push in the Company's Car i.e. TATA Safari and started to beat me mercilessly and the said Rajat Khenkar strungulat me with a rope and the other accused person hold my body and continuing punching over my body and face with an intension to kill me.
4. That I despartely tried to save myself and somehow manage to jump from the said Car which is plying towards P.B.R. Tower to Kankata More.
5. That as I jump from the said Car the above-named accused person again attack me with an intension to kill me.
6. That for the last 2 (Two) months I was not paid my salary from my above-named company and when I demanded my salary and other allowances the above-named Directors conspired to kill me and forfiet my salary and other allowances.


7. That somehow I manage to reach Siliguri District Hospital with serious injury in my whole body and the concerned attending Doctor advised me to admit immediately.
8. That the above-named accused person are very dangerous in nature and they any time kill me for fulfill their malafide intension.

Under the circumstances, I request you to take strong action against (a) Rajat Khenkar, (b) Yash Agarwal, Son of Rajesh Agarwal and (c) Rakesh Agarwal and save my life.
