Sir,

This is in continuation of my earlier FIR dt. 30.07.2024.

Sir, As per directives of the Executive Magistrate, Jalpaiguri, the officer of the BL & LRO, Rajganj came to survey the suit plot of land on 14.08.2024. Raghunath Kar and Krishna Kar did not allow the officer to enter into the land illegally. They even refused to show the required documents viz. Deeds, Khatian, Khajna Receipt etc. Though, I had produced & shown all the documents to the officer. Sir, we could not enter into the land from my gate as Rahul Kar, S/o Raghunath Kar & Krishna Kar closed the gate from inside.

Sir, it is needless to mention here that all the offences done by Raghunath Kar, Krishna Kar and their son Rahul Kar are punishable on the following grounds:

- (i) Restraining as well as not co-operating the Govt. officer for performing his official duty,
- (ii) Entering into the suit plot of land in spite of injunction imposed by the Hon'ble Court; thus violating the Order of the Court intentionally.
- (iii) Closing the door of my gate from inside for which the officer of the BL & LRO could not undertake his allotted job and left the spot.

I shall be grateful if you kindly take suitable action immediately on the above mentioned offences. I would also request you kindly to do the needful to open the closed gate from inside early.
