
Subject- Written Complaint

I, Smt. Birta Roy, w/o- Sri Bijay Roy, housewife by occupation, resident of Pabitra Nagar, Near Mother Teresa School, Champasari main Road, P.O.-Pradhan Nagar, P.S.- Pradhan Nagar, Dist- Darjeeling, Pin-734003, West Bengal would like to draw your kind attention towards the following facts:-

1. That I have been married to Sri Bijay Roy, S/o- Bindaram Roy, resident of Pabitra Nagar, Near Mother Teresa School, Champasari main Road, P.O.- Pradhan Nagar, P.S.- Pradhan Nagar, Dist- Darjeeling, Pin-734003, West Bengal at about 15 years ago at my parental house i.e. 134 Panishala, P.O.- Kamar Changrabanda, P.S- Mekhliganj, District- Coochbehar, according to Hindu rites and rituals.
2. That after solemnization of said marriage I came to my matrimonial house and started living there as husband and wife happily and there was no any problem between us.
3. That on 10-10-2013 one baby girl namely Nidhi Roy was born and on 28-10-2014 another baby girl namely Niti Roy was born out of our said wed lock and we were leaving happily as family and my husband looks after us very carefully.
4. That from the last 4 months my husband did not come to house properly and he used to return back at our home very late night and he also did not look after us nor me not our children properly.
5. That from some neighbors it came to my knowledge that my husband has married a woman namely Nikita Roy and living as husband and wife at Battalla, Samar Nagar, Champasari in a rehted house.

6. That after knowing this I several time tried to contact my husband and begged before him to return back to our house and to look after us but he categorically denied the same and due to this I am unable to maintain myself and my children,
7. That on 20st Day of September 2024, when I was at my home along with my childrens suddenly my husband came to our house and started assaulting me and childrens, when I asked the reason for the same he told me that he will kill me and my children as he wants to stay with the said Nikita Roy and her girl baby at his house.
8. That when I protest against this and told him that I will inform this to my family members and Police then he hit me on my head with a wooden stick and stone and thrashed me on the floor and beat me with fist and blow after that I became unconscious that after listening hue and cry neighbors rescued me and took me to the Siliguri District Hospital and later I informed this matter to my family members.

That on the above circumstances I pray before you to kindly look into this matter and take proper steps as per penal provisions of law and save me from my husband.

This is for you information and necessary action.
