I Rabiya Begam, wife of Md. Amin, resident of Iskcon Mandir Road, Gital Para, Ward No. 40, P.S. Bhaktinagar, Dist:- Jalpaigur, begs to state as follows:-

1. That today i.e 22/09/2024 at about 7:50 P.M. to 8:00 P.M. my daughter namely Ayshea Khatun was returning home on the way near Mount View School, few people namely (1) Rozi Khatun, (2) Ruhi Khatun, (3) Salahaya Khatun, (4) Sakhi Khatun, (5) Janatul Firdosh, (6) Sahil Kadir, forcefully obstructed the way of my daughter and on questioning they all together started abusing in filthy language and caught hold of my daughters hair log and dragged her in the middle of the road and torn her cloths.
2. That after hearing I along with my son reached the spot and saw my daughter in a miserable condition where she had received multiples injuries on all over her body and was crying in pain and all the above named persons had beaten and left my daughter to die there fled away and no one came for the help as they all are dangerous in nature and has a very ill reputation the entire society.

3. That some how we took my daughter at home but seeing her condition we could not keep her at home as she was crying in pain due to multiple injuries on all over her body and serious injuries on head, thereafter we took her to Siliguri District Hospital after which the doctors seeing the situation of my daughter immediately admitted her and now she is under medical treatment.

I therefore request you to kindly take necessary legal action against the afore said culprits for the justice of my daughter.
