In producing herewith following four accused persons namely 1) Sangam Saibo @ Sagar (27yrs) S/O- Lt Prem Saibo of Salugara, Majua, PO- Salugara, PS- Bhaktinagar Dist- Jalpaiguri 2) Raju Saibo @ Ladi (29yrs) S/O- Dhanlal Saibo of Limbu Busty, Salugara, PS- Bhaktinagar Dist- Jalpaiguri 3) Rohit Sherpa @ Nanu (25yrs) S/O- Lt Kiran Sherpa of Shastrinagar, Amtala, ward no 41, PS- Bhaktinagar Dist- Jalpaiguri 4) Bikram Paswan @ Billu (28yrs) S/O- Lt Dilip Paswan of Prakash nagar, Paswan Busty, PS-Bhaktinagar, Dist- Jalpaiguri with following seized articles viz:

- 1) One iron made knife approx 10 cm in length recovered from the exclusive and conscious possession of Sangam Saibo @ Sagar.
- 2) One iron made hacksaw blade approx 14 cm in length recovered from the exclusive and conscious possession of Raju Saibo.
- 3) One iron hammer with wooden but recovered from the exclusive and conscious possession of Bikram Paswan @ Billu.
- 4) One iron made hand Sickle approx 12 cm in length recovered from the exclusive and conscious possession Of Rohit Sherpa @ nanu

I, ASI Dipak Karmakar S/O Lt Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 1) Sangam Saibo @ Sagar (27yrs) S/O- Lt Prem Saibo of Salugara, Majua, PO- Salugara, PS- Bhaktinagar Dist- Jalpaiguri 2) Raju Saibo @ Ladi (29yrs) S/O- Dhanlal Saibo of Limbu Busty, Salugara, PS- Bhaktinagar Dist- Jalpaiguri 3) Rohit Sherpa @ Nanu (25yrs) S/O- Lt Kiran Sherpa of Shastrinagar, Amtala, ward no 41, PS- Bhaktinagar Dist- Jalpaiguri 4) Bikram Paswan @ Billu (28yrs) S/O- Lt Dilip Paswan of Prakash nagar, Paswan Busty, PS-Bhaktinagar, Dist- Jalpaiguri and 5/6 others to the effect that on 24.09.2024 at 00:10 hrs received a specific source information that 9/10 miscreants have assembled at the Donbosco road in front of Seilesen College under Bharktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 1402/24 dated 24.09.2024 and as per order I along with SI Srimanta Chatterjee, SI Youel lepcha, ASI Khagen Barman and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Donbosco road in front of Seilesen College under Bharktinagar PS, to work out the information in hand.

At about 00.35 hrs we arrived at Donbosco road in front of Seilesen College under Bharktinagar PS, as indicated by the source we noticed that 09/10 persons assembled at Donbosco road in front of Seilesen College under Bharktinagar PS and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 5/6 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 24/09/2024 in between 00.50 hrs to 01.15 hrs. The whole process of search and seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely 1) Sangam Saibo @ Sagar (27yrs) S/O- Lt Prem Saibo of Salugara, Majua, PO- Salugara, PS- Bhaktinagar Dist- Jalpaiguri 2) Raju Saibo @ Ladi (29yrs) S/O- Dhanlal Saibo of Limbu Busty, Salugara, PS- Bhaktinagar Dist- Jalpaiguri 3) Rohit Sherpa @ Nanu (25yrs) S/O- Lt Kiran Sherpa of Shastrinagar, Amtala, PS- Bhaktinagar Dist- Jalpaiguri 4) Bikram Paswan@ Billu (28yrs) S/O- Lt Dilip Paswan of Prakash nagar, Paswan Busty, PS-Bhaktinagar, Dist-Jalpaiguri and others kindly arrange for its investigation
