This is to inform you that I, Satya Narayan Sharma, So Late Kanhaiya Lal Sharma @ Purohit, resident of Nehru Road, Khalpara, Siliguri, have some properties at vill: Nethrana in the state of Rajasthan and also a house property at Nehru Road, khalpara Siliguri.

That I have one brother namely Krishna Kumar Sharma, who took me to Siliguri from Rajasthan in the month of March, 2020 and kept me with him in his house at Haripur, NJP PS Bhaktinagar. My said brother fraudulently took a Power of Attorney from me in favour of his son namely Sandip Sharma, by taking the a fraudulent Power of Attorney, my brother sold my property situated at Rajasthan and misappropriated the consideration money. He also managed to obtain a Deed of Gift in his favour in respect of my 25% share in the house property situated at Nehru Road, Khalpara, Siliguri, in his name on the strength of the aforesaid fraudulent Power of Attorney.

This is also to inform you that my said brother intentionally kept me confined in a rehabilitation centre against my will and without the knowledge and consent of my wife and daughter though I had no necessity for treatment in any rehabilitation centre. Thereafter, my daughter, filed a complaint on 27.08.24 to your police station and a case, being Siliguri PS case No.791/24 dated 28.08.24 u/s 406/420/365/120B of IPC, was started against the said Krishna Kumar Sharma and a writ petition has been filed by my daughter before the Hon'ble Calcutta High Court at Jalpaiguri and thereafter my said brother made me free and recovered me from the said so called mental rehabilitation centre.
