I, Manish Lal, S/o Lt. Praja Rajan Roy, resident
of #A-1 (Ground floor), Sharda Paradise (near Blue
mountain club), Salbari, do hereby lodge this
complaint against Bikas Pradhan a.k.a Raja, resident
of Behind S.I.T. Siliguri, Mobile No. - 9832034520.

FACTS OF THE CASE:

On 18/09/2024, at approx. 06:50 pm, I returned
home from court with my wife. Coincidentally,
Bikas Pradhan was at my residence gate,
waiting for me with an unknown person.
I parked my vehicle and handed over my
bag to my house help and instructed her to

Kept it inside the Puja room. At the same time I made Bikas and his friend sit in the outside Veranda area. They were served water and coffee by my househelp. I sent my house help to a nearby shop. Bikas Pradhan immediately started feeling uncomfortable and walked inside my house to drink water and returned back in approx. 5 min time (Please note, the bag kept in the Puja room is clearly visible from around kitchen door).

On return from the kitchen Bikas Pradhan sat at a distance and he was a little lost and showed sign of uneasiness, and finally they left my place at around 08.40 pm.

On 19/09/2024 morning, I was supposed to be present at the court again. There, when I was asked for my original set of documents by my lawyer, I couldn't find that folder, containing all the original documents inside my bag. I started searching frantically and

my lawyers also confirmed me that that I had kept it back safely inside the bag at the court room on 18th evening which I also remember very clearly.

After finishing with the court proceedings we (wife and me) headed back straight for home. We all started searching for the folder, containing the original documents and at the same time, I recieved a call from Bikas Pradhan for some casual talks (which normally he doesn't do) I straightaway questioned him regarding my missing folder repeatedly but without taking any offence he started beating around the bush and asked me to carry on with the search.

Here I would like to draw your attention to the origin of my problem. Please note that I am fighting a legal battle against my manager who was referred to me by Mr. Bikas Pradhan. Some days back when my problem had aggravated with my manager and I had called Mr. Bikas

Pradhan for his help, two - three times, he was very reluctant to intervene and he had never contacted me

On 18/09/2024, we had gone to file a case at the commercial court, Paurvahan Nagar and we were called on the 19th again and Bikas Pradhan coming to my place on the 18th evening clearly indicates that he had come to collect information about the case and he got a golden opportunity to steal my original documents from the bag. I am now sure that this was the actual reason for him sitting at a distance from me with an uneasiness.

Sir, I would request you for an immediate action on Bikas Pradhan for his misdeed. The stolen documents are very important for me. I have full faith in the police that you will help me recover my documents from Bikas Pradhan's Possession.

Sir, It is pertinent to mention here that there was no visitors in my house, other

than Bikas and his friend from the 18th evening till the 19th morning and till the time we returned from the court.
